Under applicable rules¹, the Renewable Energy (RE) Registrar is mandated to issue a Preliminary Renewable Energy Certificate (REC) Statement no later than forty-five (45) calendar days after the end of an RPS Compliance Period, and a Final REC Statement no later than ten (10) working days after the last day of an RPS Compliance Period, while RPS Mandated Participants are required to surrender their RECs within one (1) year from the last day of an RPS Compliance Period.

The DOE notes, however, that the Preliminary and Final REC Statements for Compliance Years 2020 to 2024 are yet to be issued. As a result, each RPS Mandated Participant's RPS Requirement and Compliance Level for said years could not be determined.

To address the foregoing and for IEMOP to issue updated REC Statement Reports, all RPS Mandated Participants in On-Grid Areas shall:

- 1. Submit, through the Philippine Renewable Energy Market System (PREMS), the Gross Electricity Sales (GES) data for the relevant RPS Compliance Period; and
- 2. Surrender, through the PREMS, the RECs for the relevant RPS Compliance Period.

Further, the GES/RECs shall be submitted/surrendered in accordance with the RPS Compliance Timeline below:

Concerned Distribution Utilities are hereby enjoined to submit through the PREMS the complete Metered Quantity Data no later than sixty (60) working days upon publication of this Advisory for the following Voluntary RE Facilities:

- 1. Embedded Non-WESM RE Facility with PSA;
- 2. Net-Metered RE Facilities: and
- 3. Entities with RE Generation Facilities for own-use.

Consistent with Section 27(d)3 of the RPS On-Grid Rules, failure to comply with the foregoing shall be deemed a violation under Section 234 thereof and meted the appropriate penalty pursuant to DC No. DC2023-12-0032.5

³ "Section 27. Reportorial Requirements. The DOE shall establish a reliable database to serve as the baseline in calculating and monitoring the compliance of the Mandated Participants. To this end, the DUs, Generators and the National Grid Corporation of the Philippines (NGCP) are mandated to submit the following documents within six (6) months from the effectivity of this Circular:

⁽d) Each Mandated Participant shall submit to the DOE a report containing total sales, Net Electricity Sales and eligible RECs thereof; xxx."

⁴ "Section 23. Prohibited Act. Pursuant to Section 35(a) of the RE Act, non-compliance or violation of the RPS On-Grid Rules by any Mandated Participant under this Circular shall be subject to the administrative penalties herein provided.
