



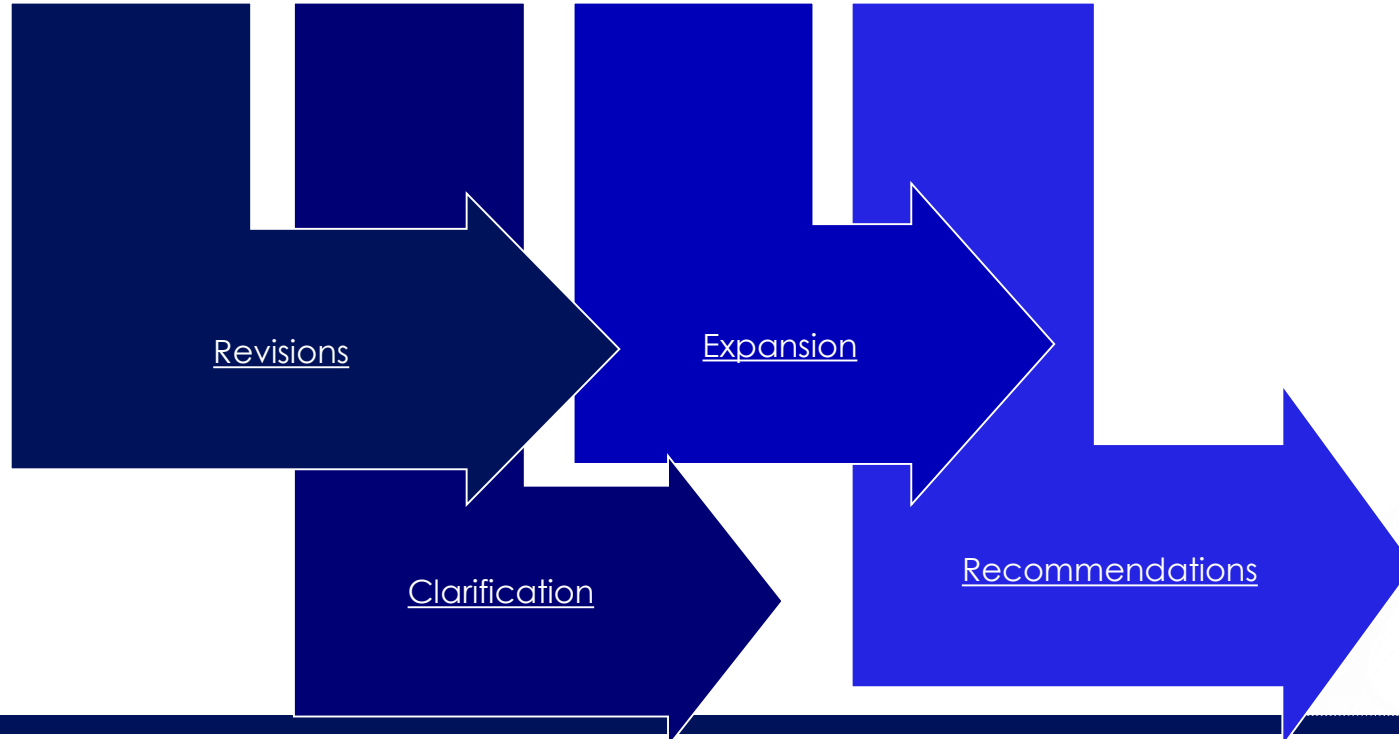

- Sec. 8: Regulatory Support



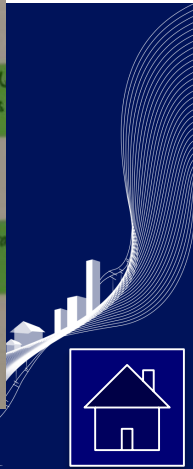
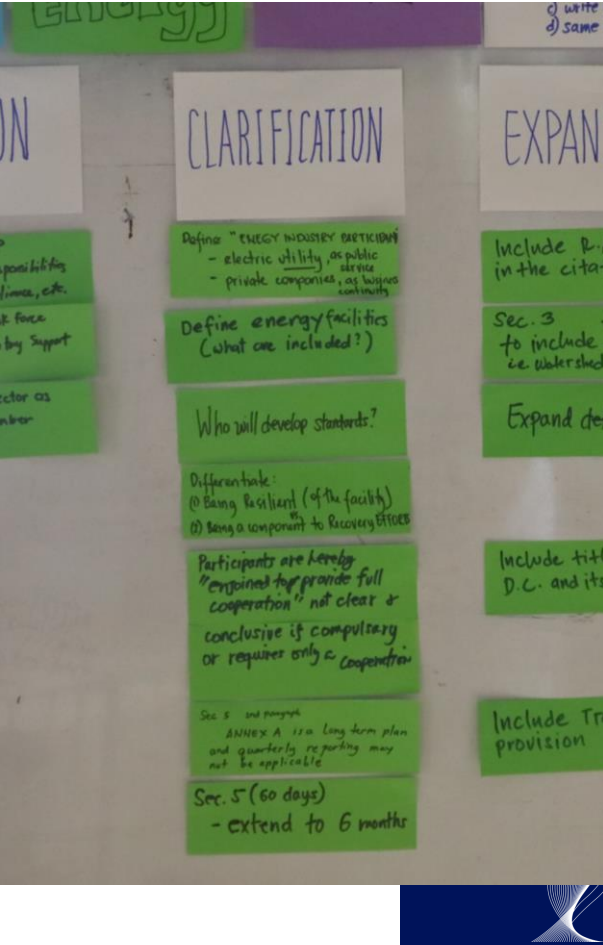

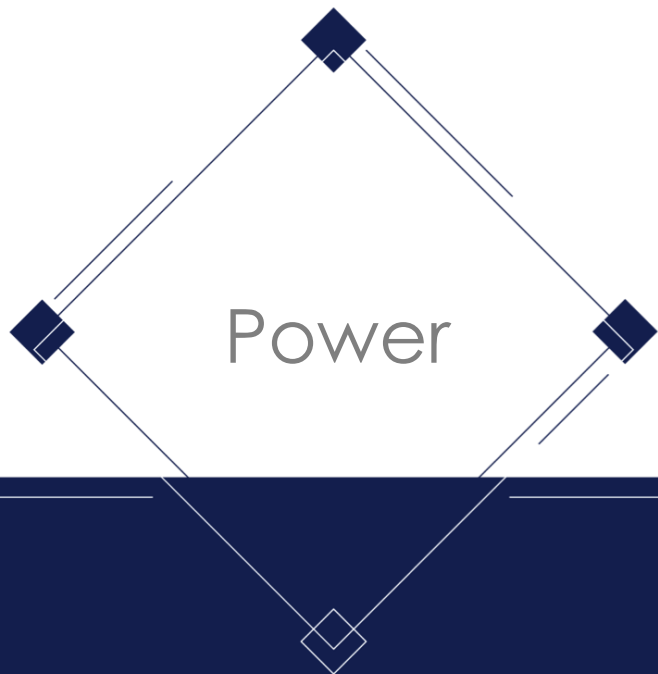
- Include the RCP in the workplan and budget (Provide Funds)

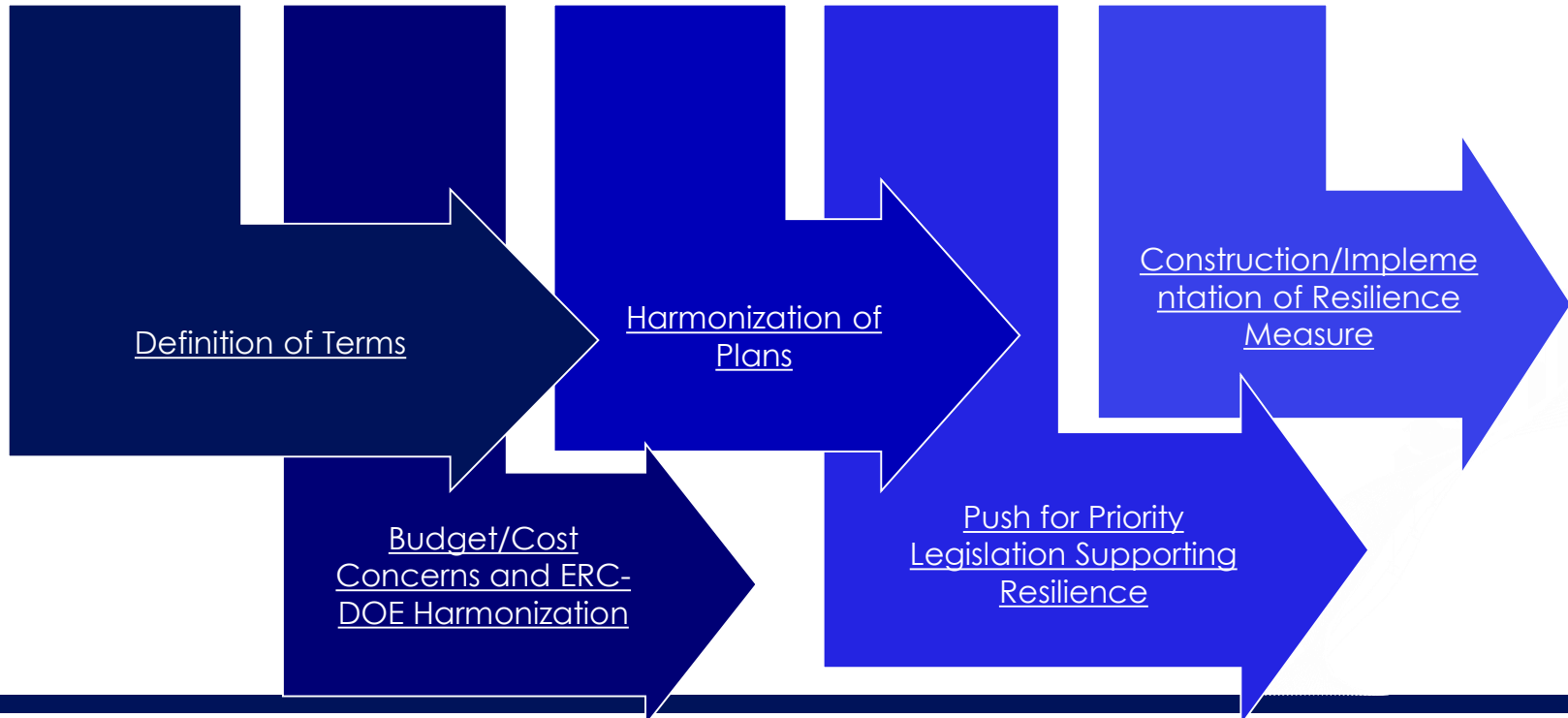

Priorities - Power



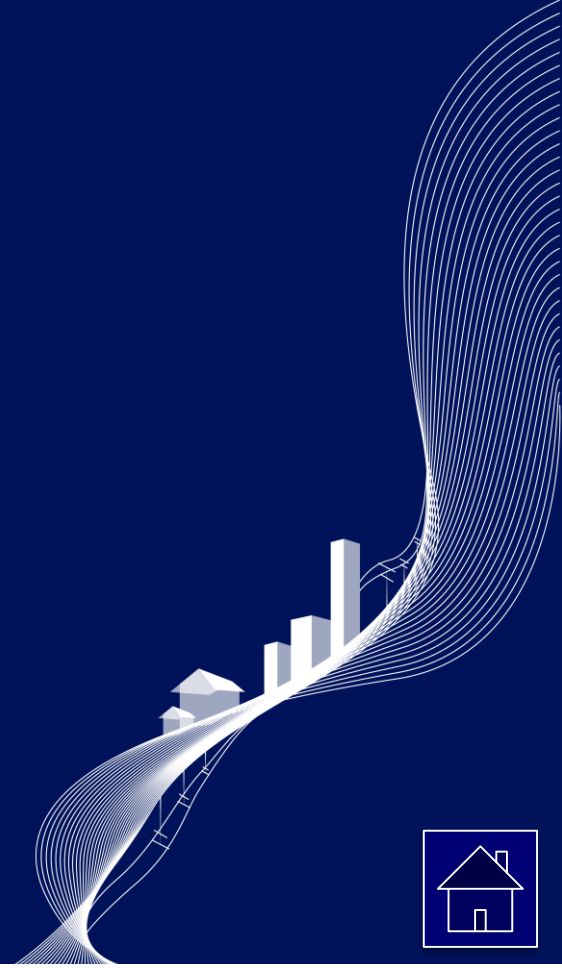

Definition of Terms

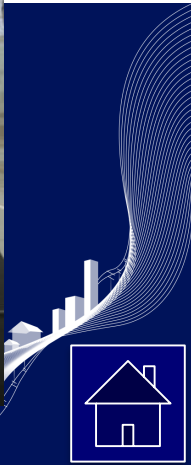
- Include definition of terms
- What do we mean by “System Recovery” – Annex “A”
- How do we define the word serious in Sec. 1, to qualify an event as a disaster
- What is the purpose of including “budgetary requirements” in Sec. 5, Annex “A”. Presently both OPEX and CAPEX are for the account of respective DU/EC
- Include under definition of terms for disaster – insurgency, external sabotage
- Description of each of the RCP – Include rescue in RCP
- Definition of terms should be consistent with the terminology used in R.A. 10121
- Sec. 7: Guidelines to support the implementation
- Definition of Manmade/Human Induced/ Force Majeure be harmonized





Budget/Cost Concerns and ERC-DOE Harmonization

- The Submission of budgetary requirements for RCP must be done annually not quarterly
- Based on Section 7 of the Circular, it is our high concern on the extent of support ERC could provide on the approval of resiliency project costs through the help of DOE as a liason officer
- DOE and ERC should establish a mechanism for the recovery of costs incurred by the Dist. Utilities
- Consider that any implementation of projects by DUs/ECs must first undergo the approval of ERC pursuant to Public Service Act
- Include ERC/NEA as the case may be, in the task force, in order to ensure end to end implementation of projects through the execution of a joint memorandum circular/ resolution
- Define, put in place enabling mechanisms with other concerned agencies

Harmonization of Plans (TDP+DDP+RCP..)



- Alignment of RCP in the Preparation of TDP
- Improve distribution development plan submitted by DUs to the DOE to include resiliency as a part of the planning process/considerations to avoid duplicity
- Can we include people continuity plan on the general policies, principles since we know that their participation of availability plays an important part in restoration
- Consider harmonization with the performance assessment audit policy guidelines
- Harmonize resiliency plans w/ telcos
- Enhance integration of RCP from Generation, transmission, distribution
- Clarify/harmonize planning timeline

Push for Priority Legislation supporting resilience

- Implementation of NGCP Projects for resiliency delayed by Right of Way Problems
- Passing/Approval of House Bill for RoW power transmission

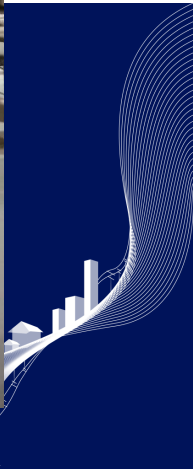

- Permits – facilitate fast tracking permits for new power projects



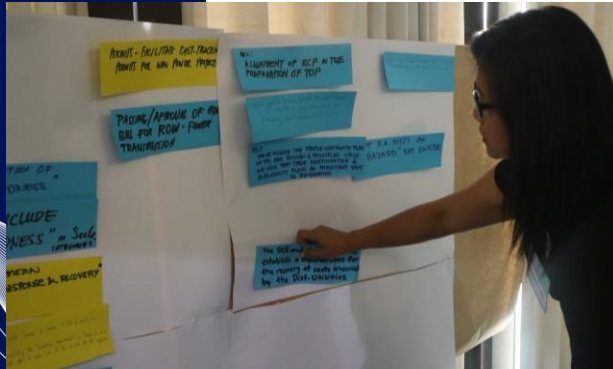

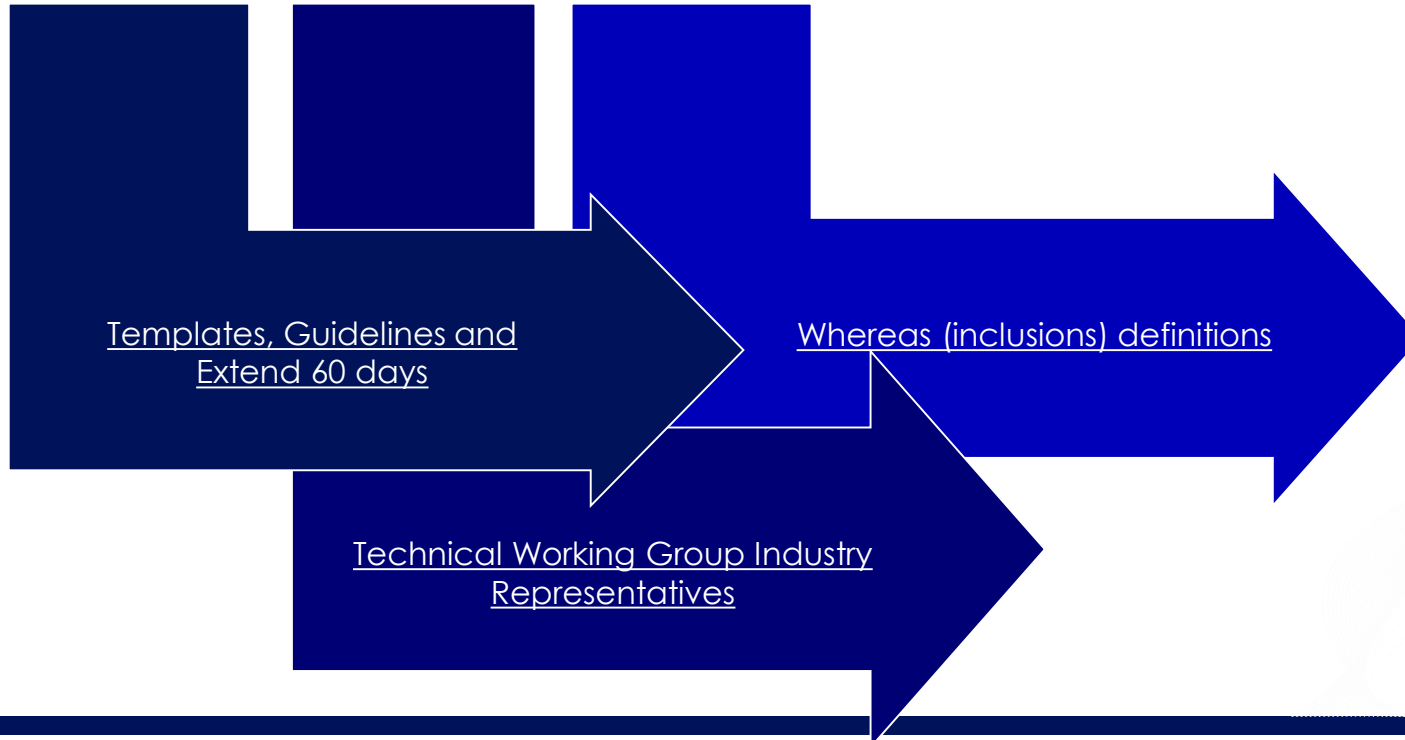

- On the 60 days Resiliency Compliance Plan (RCP) – please extend



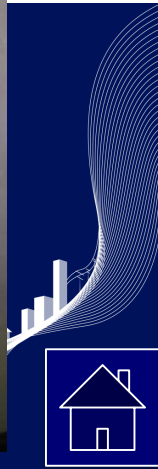
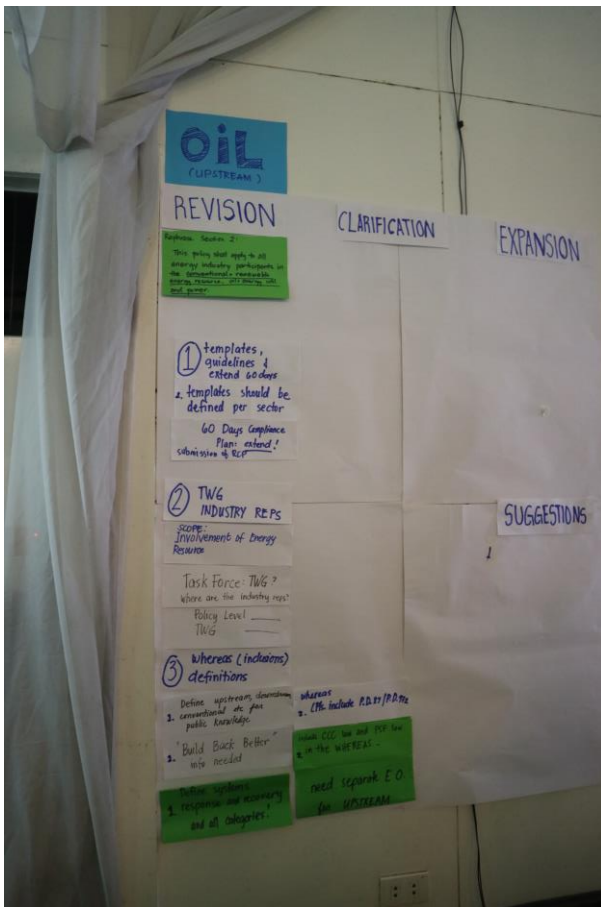

- Create a task force or TWG and identify industry representatives

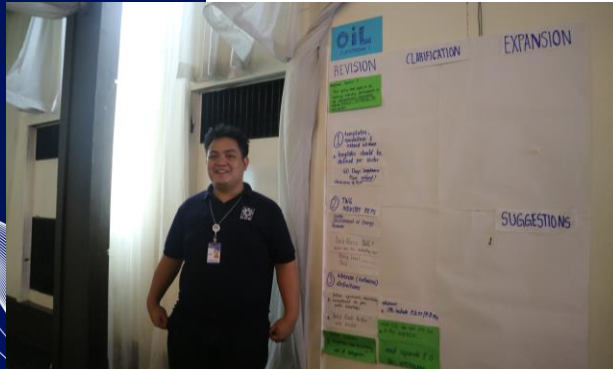
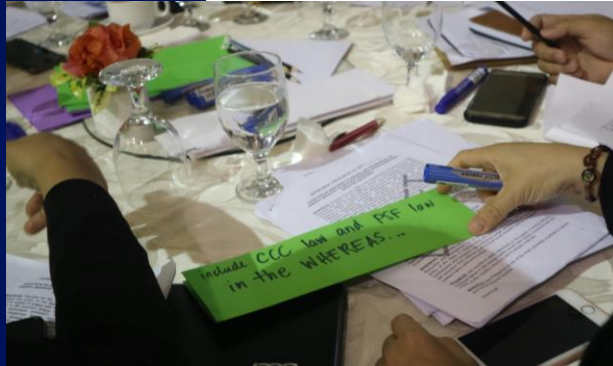
