

- Sec. 2 Scope & Application (enumerate energy industry participants)



Reliability N-1

- N-1 on Transmission and/or Distribution
- Section3: Can we put time frame for timely recovery and restoration of facilities for the power “supplier” such as NGCP so that the imposition of penalty thru rate reduction due to non-attainment of target dates? Otherwise, we should ensure the N-1 standard

- Network technology SCADA; smart grid



- DPWH-DENR-EC Row concerns
- What is the status of House Bill on Right-of-Way for Transmission Lines
- Section 3 C: Force implementation of the 3 meters clearing operation of distribution lines
- Section 7: Provide blanket authority – NGCP, ECs, DENR and PCA)
- Policy that will include DPWH infra projects
- Section 3 B: Coordination of government and private sectors/authorities for Emergency Restoration Plan



Accessibility of Funds


- Financing and Budgetary Allocations


Resiliency Criteria, Indicators and Standards
