#### A. Introduction

1. This has reference to DOE's CY2023 Primary Internet Access Services project which was awarded to CONVERGE ICT SOLUTIONS, INC.

#### B. Mandate

- 2. The Information and Technology Management Services (ITMS) formulates policies, plans and programs relative to information and communications technology, geo-informatics, and data and information management, and ensures effective implementation thereof and compliance with government rules, regulations and standards.
- 3. The Information and Technology Division formulates and implements the Department's policies, programs and government regulations and standards on Information Communication Technology (ICT)

## C. FACTS OR BACKGROUND

- 4. The Bids and Awards Committee (BAC) conducted public bidding for the procurement of services for the DOE CY2023 Primary Internet Access with an approved budget for the contract (ABC) in the amount of Php4,700,000.00 on 09 December 2022.
- 5. Thru BAC Resolution No. 005, s. 2023, the contract amounting to Php1,963,872.00 was awarded to Converge ICT Solutions, Inc. being the Lowest Calculated Responsive Bidder (LCRB).
- 6. Notice of Award (NOA) was received by the winning internet service provider (ISP) last February 20, 2023.
