## **CONTRACT AGREEMENT**

THIS AGREEMENT made the \_\_\_\_\_ day AR 2 0 2023 between **DEPARTMENT OF ENERGY (DOE)** of the Philippines (hereinafter called "the Entity") of the one part and **WIFICITY, INC.** of **Suite 3903-3905 Discovery Center, 25 ADB Ave., Ortigas Center, Pasig City** (hereinafter called "the Service Provider") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Services for the DOE CY2023 Secondary Internet Access and has accepted a Bid by the Service Provider for manpower services in the sum of *Eight Hundred Ninety-Nine Thousand Eight Hundred Eighty Pesos Only (Php899,880.00)* for ten (10) months from March to December 2023 (hereinafter called "the Contract Price").

  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract;
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of *Eight Hundred Ninety-Nine Thousand Eight Hundred Eighty Pesos Only (Php899,880.00)* or such other sums as may be ascertained, *WifiCity, Inc.* agrees to the *Services for the DOE CY2023 Secondary Internet Access* in accordance with its Bid.
- 4. The **Department of Energy** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
