

## CY 2022 CONTRACT ON SHUTTLE SERVICES FOR DOE MAIN OFFICE

THIS CONTRACT made this \_\_\_\_ day of \_\_\_\_\_ 2022 by and between the **DEPARTMENT OF ENERGY (DOE)** with office address at Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila, Philippines (hereinafter called "**the Entity**") of the one part, and **MG PACIFIC TRANS CORPORATION** with principal place of business located at Km. 54, Manila East Road, Barangay Tandang Kutyo, Tanay, Rizal, Philippines (hereinafter called "**the Contractor**") of the other part.

**WHEREAS**, the Entity invited Bids for certain goods and ancillary services, viz., the **Shuttle Services for the Department of Energy (DOE)** and has accepted a Bid by the Contractor in the sum of **Twelve Million Eight Hundred Sixty-Three Thousand Pesos (P12,863,000.00)** for nine (9) months period or **Sixty-Seven Thousand Seven Hundred Pesos (P67,700.00)** per day inclusive of VAT (hereinafter called "**the Contract Price**").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Contract referred to below.

*Note: On Item IV (Scope of Works) – Section 6 and 7 of the Terms of Reference (TOR), the route of Calamba and San Pedro in Laguna which comprises two (2) passenger vans with twenty-eight (28) total passenger capacity will be replaced with one (1) unit mini-bus with seating capacity of thirty-three (33) seats with no additional cost*

5. The Entity hereby covenants to pay the Contractor in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by the Contract, subject to applicable withholding tax.






