I. INTRODUCTION

In relation to the implementation of Republic Act (R.A.) 11285 or The Energy Efficiency & Conservation Act and its subsequent policy issuances, particularly Section 4 (m), Rule III of the Implementing Rules and Regulations (IRR) of the EE&C Act, mandates the DOE to develop and undertake a national awareness and advocacy campaign on energy efficiency and conservation in partnership with business, academe, non-government organizations, and other sectors.

II. MANDATE

 The EUMB formulates polices, plans and programs related to Energy Efficiency and Conservation and Alternative Fuels and Energy Technologies, and ensure effective implementation thereof to enhance energy security through diversification of energy sources, and address climate change.

- 4. On 01 March 2023, the EUMB submitted the draft Contract Agreement to Legal Services for the review of the above subject Contract Agreement between DOE and CNN Philippines.

The DOE Legal Services, in its Memorandum dated 08 March 2023 provided their legal opinion on the draft Contract Agreement and have determined that it complies with all applicable laws, rules and regulations governing public procurement. As a result, they find the same as valid and to be legally in order.
