CONTRACT AGREEMENT

THIS AGREEMENT made the 2023 between **DEPARTMENT** OF ENERGY (DOE) of the Philippines (hereinafter called "the Entity") of the one part and QUARTZ BUSINESS PRODUCTS CORPORATION of 15th Capital House 9th Ave. cor. 34th St. Bonifacio Global City Fort Bonifacio, Taguig (hereinafter called "the Service Provider") of the other part;

 - Supplemental or Bid Bulletins, if any iv
 - Winning bidder's bid, including the Eligibility requirements, Technical and ii. Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security:
- Notice of Award of Contract; and the Bidder's conforme thereto; and iv.
- Other contract documents that may be required by existing laws and/or the v. Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of Four Hundred Sixty-Six Thousand Three 3. Hundred Eighty Pesos Only (Php466,380.00) or such other sums as may be ascertained, Quartz Business Products Corporation agrees to the ICT Supplies and Various Printer Inks under NEECP (Lot 2) in accordance with its Bid.
- The **Department of Energy** agrees to pay the above-mentioned sum in accordance 4. with the terms of the Bidding.
