# INVITATION TO BID FOR (Re-bidding) Services for the DOE Fixed Wireless Internet Access for CY2025

- 1. The **Department of Energy (DOE)**, through the **General Appropriations Act 2025** intends to apply the sum of **Php2,500,000.00**, being the ABC to payments under the contract for (**Re-bidding**) **Services for the DOE Fixed Wireless Internet Access for CY2025**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **Department of Energy (DOE)** now invites bids for the above Procurement Project. Delivery of the Goods and Services is required **Thirty (30)** Calendar Days upon receipt of Notice to Proceed. Bidders should have completed, within two (2) years from the date of submission and receipt of bid, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

- 4. Prospective Bidders may obtain further information from **Department of Energy Procurement Management Division** and inspect the Bidding Documents at the address given below during office hours from Mondays to Fridays from 8:00am to 4:00pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on **01 May 2025** from the given address and website(s) below and upon payment of the applicable fee, for the Bidding Documents, pursuant to Section 5 of Appendix 8 of the 2016 IRR of RA 9184 in the amount of **Php2,500.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees [specify the manner if it will be presented in person, by facsimile, or through electronic means.]

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on **22 May 2025 at 09:00AM, DOE Audio Visual Room, DOE Main Building.** Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. To minimize errors in the preparation of bids, bidders are strongly encouraged to send the person or representative actually preparing their bids to attend/participate in the Prebid Conference. The bidders' representative shall carefully consider all the discussions during the Pre-bid Conference and be guided by them in the preparation of bids.

Official communication or notification shall be sent through the official email provided by the suppliers and are considered official and duly received by the supplier even without confirmation of such receipt.

- 11. The **Department of Energy (DOE)** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders

# Section II. Instructions to Bidders

# **Notes on the Instructions to Bidders**

This Section on the Instruction to Bidders (ITB) provides the information necessary for bidders to prepare responsive bids, in accordance with the requirements of the Procuring Entity. It also provides information on bid submission, eligibility check, opening and evaluation of bids, post-qualification, and on the award of contract.

## 1. Scope of Bid

The Procuring Entity, **Department of Energy (DOE)** wishes to receive Bids for the (Re-bidding) Services for the DOE Fixed Wireless Internet Access for CY2025 under Purchase Request No. 02-0101- 2025-01-0010

The Procurement Project (referred to herein as "Project") is composed of **One** (1) **Lot**, the details of which are described in Section VII (Technical Specifications).

## 2. Funding Information

- 2.1. The GOP through the source of funding as indicated below for **General Appropriations Act (GAA) 2025** in the amount of **Php2,500,000.00**.
- 2.2. The source of funding is:

NGA, the General Appropriations Act or Special Appropriations.

# 3. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manuals and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.

Any amendments made to the IRR and other GPPB issuances shall be applicable only to the ongoing posting, advertisement, or **IB** by the BAC through the issuance of a supplemental or bid bulletin.

The Bidder, by the act of submitting its Bid, shall be deemed to have verified and accepted the general requirements of this Project, including other factors that may affect the cost, duration and execution or implementation of the contract, project, or work and examine all instructions, forms, terms, and project requirements in the Bidding Documents.

# 4. Corrupt, Fraudulent, Collusive, and Coercive Practices

The Procuring Entity, as well as the Bidders and Suppliers, shall observe the highest standard of ethics during the procurement and execution of the contract. They or through an agent shall not engage in corrupt, fraudulent, collusive, coercive, and obstructive practices defined under Annex "I" of the 2016 revised IRR of RA No. 9184 or other integrity violations in competing for the Project.

# 5. Eligible Bidders

5.1. Only Bids of Bidders found to be legally, technically, and financially capable will be evaluated.

- 5.2. Foreign ownership limited to those allowed under the rules may participate in this Project.
- 5.3. Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No.9184, the Bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA's CPI, must be at least equivalent to:
  - a. For the procurement of Non-expendable Supplies and Services: The Bidder must have completed a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC.
  - b. For procurement where the Procuring Entity has determined, after the conduct of market research, that imposition of either (a) or (b) will likely result to failure of bidding or monopoly that will defeat the purpose of public bidding: the Bidder should comply with the following requirements:
    - i. Completed at least two (2) similar contracts, the aggregate amount of which should be equivalent to at least fifty percent (50%) in the case of non-expendable supplies and services or twenty-five percent (25%) in the case of expendable supplies] of the ABC for this Project; and
- 5.4. The Bidders shall comply with the eligibility criteria under Section 23.4.1 of the 2016 IRR of RA No. 9184.

# 6. Origin of Goods

There is no restriction on the origin of goods other than those prohibited by a decision of the UN Security Council taken under Chapter VII of the Charter of the UN, subject to Domestic Preference requirements under **ITB** Clause 18.

#### 7. Subcontracts

7.1. The Bidder may subcontract portions of the Project to the extent allowed by the Procuring Entity as stated herein, but in no case more than twenty percent (20%) of the Project.

The Procuring Entity has prescribed that:

a. Subcontracting is not allowed.

#### 8. Pre-Bid Conference

The Procuring Entity will hold a pre-bid conference for this Project on the specified date and time and either at its physical address **08 May 2025** which **will start at 08:00 AM** at the **DOE** – **Audio Visual Room DOE BAC Main Office** as indicated in paragraph 6 of the **IB.** 

# 9. Clarification and Amendment of Bidding Documents

Prospective bidders may request for clarification on and/or interpretation of any part of the Bidding Documents. Such requests must be in writing and received by the Procuring Entity, either at its given address or through electronic mail indicated in the **IB**, at least ten (10) calendar days before the deadline set for the submission and receipt of Bids.

#### 10. Documents comprising the Bid: Eligibility and Technical Components

- 10.1. The first envelope shall contain the eligibility and technical documents of the Bid as specified in **Section VIII** (Checklist of Technical and Financial **Documents**).
- 10.2. The Bidder's SLCC as indicated in **ITB** Clause 5.3 should have been completed within **two (2) years** prior to the deadline for the submission and receipt of bids.
- 10.3. If the eligibility requirements or statements, the bids, and all other documents for submission to the BAC are in foreign language other than English, it must be accompanied by a translation in English, which shall be authenticated by the appropriate Philippine foreign service establishment, post, or the equivalent office having jurisdiction over the foreign bidder's affairs in the Philippines. Similar to the required authentication above, for Contracting Parties to the Apostille Convention, only the translated documents shall be authenticated through an apostille pursuant to GPPB Resolution No. 13-2019 dated 23 May 2019. The English translation shall govern, for purposes of interpretation of the bid.

#### 11. Documents comprising the Bid: Financial Component

- 11.1. The second bid envelope shall contain the financial documents for the Bid as specified in **Section VIII** (Checklist of Technical and Financial Documents).
- 11.2. If the Bidder claims preference as a Domestic Bidder or Domestic Entity, a certification issued by DTI shall be provided by the Bidder in accordance with Section 43.1.3 of the 2016 revised IRR of RA No. 9184.
- 11.3. Any bid exceeding the ABC indicated in paragraph 1 of the **IB** shall not be accepted.
- 11.4. For Foreign-funded Procurement, a ceiling may be applied to bid prices provided the conditions are met under Section 31.2 of the 2016 revised IRR of RA No. 9184.

#### 12. Bid Prices

- 12.1. Prices indicated on the Price Schedule shall be entered separately in the following manner:
  - a. For Goods offered from within the Procuring Entity's country:

- The price of the Goods quoted EXW (ex-works, ex-factory, exi. warehouse, ex-showroom, or off-the-shelf, as applicable);
- ii. The cost of all customs duties and sales and other taxes already paid or payable;
- The cost of transportation, insurance, and other costs incidental to iii. delivery of the Goods to their final destination; and
- iv. The price of other (incidental) services, if any, listed in the **BDS**.
- For Goods offered from abroad:
  - i. Unless otherwise stated in the **BDS**, the price of the Goods shall be quoted delivered duty paid (DDP) with the place of destination in the Philippines as specified in the **BDS**. In quoting the price, the Bidder shall be free to use transportation through carriers registered in any eligible country. Similarly, the Bidder may obtain insurance services from any eligible source country.
  - ii. The price of other (incidental) services, if any, as listed in the **BDS**.

#### 13. Bid and Payment Currencies

- For Goods that the Bidder will supply from outside the Philippines, the bid prices may be quoted in the local currency or tradeable currency accepted by the BSP at the discretion of the Bidder. However, for purposes of bid evaluation, Bids denominated in foreign currencies, shall be converted to Philippine currency based on the exchange rate as published in the BSP reference rate bulletin on the day of the bid opening.
- 13.2. Payment of the contract price shall be made in:

#### Philippine Pesos.

# 14. Bid Security

- The Bidder shall submit a Bid Securing Declaration<sup>2</sup> or any form of Bid Security in the amount indicated in the **BDS**, which shall be not less than the percentage of the ABC in accordance with the schedule in the **BDS**.
- 14.2. The Bid and bid security shall be valid until 19 September 2025. Any Bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive.

<sup>&</sup>lt;sup>2</sup> In the case of Framework Agreement, the undertaking shall refer to entering into contract with the Procuring Entity and furnishing of the performance security or the performance securing declaration within ten (10) calendar days from receipt of Notice to Execute Framework Agreement.

## 15. Sealing and Marking of Bids

Each Bidder shall submit one copy of the first and second components of its Bid.

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.

If the Procuring Entity allows the submission of bids through online submission or any other electronic means, the Bidder shall submit an electronic copy of its Bid, which must be digitally signed. An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and, thus, automatically disqualified.

#### 16. Deadline for Submission of Bids

16.1. The Bidders shall submit on the specified date and time and either at its physical address or through online submission as indicated in paragraph 7 of the **IB**.

# 17. Opening and Preliminary Examination of Bids

17.1. The BAC shall open the Bids in public at the time, on the date, and at the place specified in paragraph 9 of the **IB**. The Bidders' representatives who are present shall sign a register evidencing their attendance. In case videoconferencing, webcasting or other similar technologies will be used, attendance of participants shall likewise be recorded by the BAC Secretariat.

In case the Bids cannot be opened as scheduled due to justifiable reasons, the rescheduling requirements under Section 29 of the 2016 revised IRR of RA No. 9184 shall prevail.

17.2. The preliminary examination of bids shall be governed by Section 30 of the 2016 revised IRR of RA No. 9184.

#### 18. Domestic Preference

18.1. The Procuring Entity will grant a margin of preference for the purpose of comparison of Bids in accordance with Section 43.1.2 of the 2016 revised IRR of RA No. 9184.

# 19. Detailed Evaluation and Comparison of Bids

- 19.1. The Procuring Entity's BAC shall immediately conduct a detailed evaluation of all Bids rated "passed," using non-discretionary pass/fail criteria. The BAC shall consider the conditions in the evaluation of Bids under Section 32.2 of the 2016 revised IRR of RA No. 9184.
- 19.2. If the Project allows partial bids, bidders may submit a proposal on any of the lots or items, and evaluation will be undertaken on a per lot or item basis, as the case maybe. In this case, the Bid Security as required by **ITB** Clause 14 shall be submitted for each lot or item separately.

- 19.3. The descriptions of the lots or items shall be indicated in **Section VII** (**Technical Specifications**), although the ABCs of these lots or items are indicated in the **BDS** for purposes of the NFCC computation pursuant to Section 23.4.2.6 of the 2016 revised IRR of RA No. 9184. The NFCC must be sufficient for the total of the ABCs for all the lots or items participated in by the prospective Bidder.
- 19.4. The Project shall be awarded as follows:

#### One Project having several items that shall be awarded as one contract.

19.5. Except for bidders submitting a committed Line of Credit from a Universal or Commercial Bank in lieu of its NFCC computation, all Bids must include the NFCC computation pursuant to Section 23.4.1.4 of the 2016 revised IRR of RA No. 9184, which must be sufficient for the total of the ABCs for all the lots or items participated in by the prospective Bidder. For bidders submitting the committed Line of Credit, it must be at least equal to ten percent (10%) of the ABCs for all the lots or items participated in by the prospective Bidder.

#### 20. Post-Qualification

20.1. Within a non-extendible period of five (5) calendar days from receipt by the Bidder of the notice from the BAC that it submitted the Lowest Calculated Bid, the Bidder shall submit its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS) and other appropriate licenses and permits required by law and stated in the **BDS**.

#### 21. Signing of the Contract

21.1. The documents required in Section 37.2 of the 2016 revised IRR of RA No. 9184 shall form part of the Contract. Additional Contract documents are indicated in the **BDS**.

# Section III. Bid Data Sheet

#### **Notes on the Bid Data Sheet**

The Bid Data Sheet (BDS) consists of provisions that supplement, amend, or specify in detail, information, or requirements included in the ITB found in Section II, which are specific to each procurement.

This Section is intended to assist the Procuring Entity in providing the specific information in relation to corresponding clauses in the ITB and has to be prepared for each specific procurement.

The Procuring Entity should specify in the BDS information and requirements specific to the circumstances of the Procuring Entity, the processing of the procurement, and the bid evaluation criteria that will apply to the Bids. In preparing the BDS, the following aspects should be checked:

- a. Information that specifies and complements provisions of the ITB must be incorporated.
- b. Amendments and/or supplements, if any, to provisions of the ITB as necessitated by the circumstances of the specific procurement, must also be incorporated.

# Section IV. General Conditions of Contract

# **Notes on the General Conditions of Contract**

The General Conditions of Contract (GCC) in this Section, read in conjunction with the Special Conditions of Contract in Section V and other documents listed therein, should be a complete document expressing all the rights and obligations of the parties.

Matters governing performance of the Supplier, payments under the contract, or matters affecting the risks, rights, and obligations of the parties under the contract are included in the GCC and Special Conditions of Contract.

Any complementary information, which may be needed, shall be introduced only through the Special Conditions of Contract.

#### 1. Scope of Contract

This Contract shall include all such items, although not specifically mentioned, that can be reasonably inferred as being required for its completion as if such items were expressly mentioned herein. All the provisions of RA No. 9184 and its 2016 revised IRR, including the Generic Procurement Manual, and associated issuances, constitute the primary source for the terms and conditions of the Contract, and thus, applicable in contract implementation. Herein clauses shall serve as the secondary source for the terms and conditions of the Contract.

This is without prejudice to Sections 74.1 and 74.2 of the 2016 revised IRR of RA No. 9184 allowing the GPPB to amend the IRR, which shall be applied to all procurement activities, the advertisement, posting, or invitation of which were issued after the effectivity of the said amendment.

Additional requirements for the completion of this Contract shall be provided in the **Special Conditions of Contract (SCC).** 

#### 2. Advance Payment and Terms of Payment

- 2.1. Advance payment of the contract amount is provided under Annex "D" of the revised 2016 IRR of RA No. 9184.
- 2.2. The Procuring Entity is allowed to determine the terms of payment on the partial or staggered delivery of the Goods procured, provided such partial payment shall correspond to the value of the goods delivered and accepted in accordance with prevailing accounting and auditing rules and regulations. The terms of payment are indicated in the **SCC**.

### 3. Performance Security

Within ten (10) calendar days from receipt of the Notice of Award by the Bidder from the Procuring Entity but in no case later than the signing of the Contract by both parties, the successful Bidder shall furnish the performance security in any of the forms prescribed in Section 39 of the 2016 revised IRR of RA No. 9184.

# 4. Inspection and Tests

The Procuring Entity or its representative shall have the right to inspect and/or to test the Goods to confirm their conformity to the Project. In addition to tests in the SCC, Section VII (Technical Specifications) shall specify what inspections and/or tests the Procuring Entity requires, and where they are to be conducted. The Procuring Entity shall notify the Supplier in writing, in a timely manner, of the identity of any representatives retained for these purposes.

All reasonable facilities and assistance for the inspection and testing of Goods, including access to drawings and production data, shall be provided by the Supplier to the authorized inspectors at no charge to the Procuring Entity.

# 5. Warranty

- 5.1 In order to assure that manufacturing defects shall be corrected by the Supplier, a warranty shall be required from the Supplier as provided under Section 62.1 of the 2016 revised IRR of RA No. 9184.
- 5.2 The Procuring Entity shall promptly notify the Supplier in writing of any claims arising under this warranty. Upon receipt of such notice, the Supplier shall, repair or replace the defective Goods or parts thereof without cost to the Procuring Entity, pursuant to the Generic Procurement Manual.

# 6. Liability of the Supplier

The Supplier's liability under this Contract shall be as provided by the laws of the Republic of the Philippines.

If the Supplier is a joint venture, all partners to the joint venture shall be jointly and severally liable to the Procuring Entity.

# Section V. Special Conditions of Contract

# **Notes on the Special Conditions of Contract**

Similar to the BDS, the clauses in this Section are intended to assist the Procuring Entity in providing contract-specific information in relation to corresponding clauses in the GCC found in Section IV.

The Special Conditions of Contract (SCC) complement the GCC, specifying contractual requirements linked to the special circumstances of the Procuring Entity, the Procuring Entity's country, the sector, and the Goods purchased. In preparing this Section, the following aspects should be checked:

- a. Information that complements provisions of the GCC must be incorporated.
- b. Amendments and/or supplements to provisions of the GCC as necessitated by the circumstances of the specific purchase, must also be incorporated.

However, no special condition which defeats or negates the general intent and purpose of the provisions of the GCC should be incorporated herein.

- 2. in the event of termination of production of the spare parts:
  - i. advance notification to the Procuring Entity of the pending termination, in sufficient time to permit the Procuring Entity to procure needed requirements; and
  - ii. following such termination, furnishing at no cost to the Procuring Entity, the blueprints, drawings, and specifications of the spare parts, if requested.

The spare parts and other components required are listed in **Section VI** (**Schedule of Requirements**) and the costs thereof are included in the contract price.

#### Packaging -

The Supplier shall provide such packaging of the Goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in this Contract. The packaging shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packaging case size and weights shall take into consideration, where appropriate, the remoteness of the Goods' final destination and the absence of heavy handling facilities at all points in transit.

The packaging, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the Contract, including additional requirements, if any, specified below, and in any subsequent instructions ordered by the Procuring Entity.

The outer packaging must be clearly marked on at least four (4) sides as follows:

Where the Supplier is required under Contract to deliver the Goods CIF, CIP, or DDP, transport of the Goods to the port of destination or such other named place of destination in the Philippines, as shall be specified in this Contract, shall be arranged and paid for by the Supplier, and the cost thereof shall be included in the Contract Price.

Where the Supplier is required under this Contract to transport the Goods to a specified place of destination within the Philippines, defined as the Project Site, transport to such place of destination in the Philippines, including insurance and storage, as shall be specified in this Contract, shall be arranged by the Supplier, and related costs shall be included in the contract price.

Where the Supplier is required under Contract to deliver the Goods CIF, CIP or DDP, Goods are to be transported on carriers of Philippine registry. In the event that no carrier of Philippine registry is available, Goods may be shipped by a carrier which is not of Philippine registry provided that the Supplier obtains and presents to the Procuring Entity certification to this effect from the nearest Philippine consulate to the port of dispatch. In the event that carriers of Philippine registry are available but their schedule delays the Supplier in its performance of this Contract the period from when the Goods were first ready for shipment and the actual date of shipment the period of delay will be considered force majeure.

The Procuring Entity accepts no liability for the damage of Goods during transit other than those prescribed by INCOTERMS for DDP deliveries. In the case of Goods supplied from within the Philippines or supplied by domestic Suppliers risk and title will not be deemed to have passed to the Procuring Entity until their receipt and final acceptance at the final destination.

# Section VII. Technical Specifications

# **Notes for Preparing the Technical Specifications**

A set of precise and clear specifications is a prerequisite for Bidders to respond realistically and competitively to the requirements of the Procuring Entity without qualifying their Bids. In the context of Competitive Bidding, the specifications (*e.g.* production/delivery schedule, manpower requirements, and after-sales service/parts, descriptions of the lots or items) must be prepared to permit the widest possible competition and, at the same time, present a clear statement of the required standards of workmanship, materials, and performance of the goods and services to be procured. Only if this is done will the objectives of transparency, equity, efficiency, fairness, and economy in procurement be realized, responsiveness of bids be ensured, and the subsequent task of bid evaluation and post-qualification facilitated. The specifications should require that all items, materials and accessories to be included or incorporated in the goods be new, unused, and of the most recent or current models, and that they include or incorporate all recent improvements in design and materials unless otherwise provided in the Contract.

Samples of specifications from previous similar procurements are useful in this respect. The use of metric units is encouraged. Depending on the complexity of the goods and the repetitiveness of the type of procurement, it may be advantageous to standardize the General Technical Specifications and incorporate them in a separate subsection. The General Technical Specifications should cover all classes of workmanship, materials, and equipment commonly involved in manufacturing similar goods. Deletions or addenda should then adapt the General Technical Specifications to the particular procurement.

Care must be taken in drafting specifications to ensure that they are not restrictive. In the specification of standards for equipment, materials, and workmanship, recognized Philippine and international standards should be used as much as possible. Where other particular standards are used, whether national standards or other standards, the specifications should state that equipment, materials, and workmanship that meet other authoritative standards, and which ensure at least a substantially equal quality than the standards mentioned, will also be acceptable. The following clause may be inserted in the Special Conditions of Contract or the Technical Specifications.

#### Sample Clause: Equivalency of Standards and Codes

Wherever reference is made in the Technical Specifications to specific standards and codes to be met by the goods and materials to be furnished or tested, the provisions of the latest edition or revision of the relevant standards and codes shall apply, unless otherwise expressly stated in the Contract. Where such standards and codes are national or relate to a particular country or region, other authoritative standards that ensure substantial equivalence to the standards and codes specified will be acceptable.

Reference to brand name and catalogue number should be avoided as far as possible; where unavoidable they should always be followed by the words "or at least equivalent." References to brand names cannot be used when the funding source is the GOP.

Where appropriate, drawings, including site plans as required, may be furnished by the Procuring Entity with the Bidding Documents. Similarly, the Supplier may be requested to provide drawings or samples either with its Bid or for prior review by the Procuring Entity during contract execution.

Bidders are also required, as part of the technical specifications, to complete their statement of compliance demonstrating how the items comply with the specification.

In case of Renewal of Regular and Recurring Services, the Procuring Entity must indicate here the technical requirements for the service provider, which must include the set criteria in the conduct of its performance evaluation.

#### I. BACKGROUND

The Department of Energy (DOE) intends to procure the services of a guaranteed, fast, reliable, and no data capping internet access through fixed wireless facility.

The Service Provider (SP) shall deliver a reliable wireless internet connection facility with a dedicated internet bandwidth of at least 500 Mbps symmetrical broadband connection for the DOE.

#### II. APPROVED BUDGET FOR THE CONTRACT (ABC)

The Approved Budget for the Contract to cover the period 01 January to 31 December 2025 shall be Two Million Five Hundred Thousand Pesos (Php 2,500,000.00) only, inclusive of VAT and other charges.

#### III. SCOPE OF WORKS

- 1. The SP shall deliver, install and configure wireless internet connection equipment/devices such as microwave radio antenna/Very Small Aperture Terminal (VSAT), Gigabit PoE managed switches, routers and other appurtenances required for the fixed wireless internet connection for the DOE. The internet connection should handle at least 500 concurrent users.
- 2. The SP shall also replace the DOE's 38 existing access points (APs), located throughout the DOE Buildings and PNOC Building No. 5 (refer to Annex A), with new units of the same or better technical specifications. Ownership of these new APs shall remain with the DOE.
- 3. Upon request, the SP shall likewise provide the DOE with bandwidth at no additional cost. The DOE requirement for extra bandwidth on demand at no extra cost is 50 Mbps, which shall be provided by the SP for a maximum of 30 cumulative days within the Contract period.
- 4. The SP shall protect the fixed wireless internet access by installing and configuring a firewall appliance capable of handling at least 500 concurrent users, which shall be deployed at the DOE.
- 5. Provide an updated schematic diagram of the fixed wireless connection implementation.
- 6. Commit to a Service Level of at least 99.0% circuit availability or service uptime in a given month.

#### IV. SUPPORT AND MAINTENANCE

- 1. Provide replacement of AP units with the same or better specifications in case a unit is found defective. The AP shall become a property of the DOE.
- 2. Designate at least one focal person to act as the SP support representative that handles the DOE's concerns as regards the provision of the internet access service.
- Provide detailed incident reports within 48 hours after the occurrence of any incident (e.g., downtime, slow/intermittent connection) affecting the DOE Main Offices.
- 4. Provide a tool which does not log off to monitor bandwidth utilization, and a management tool and dashboard for monitoring and controlling the access points connected to the fixed wireless LAN.
- 5. Hold an inception/kick-off meeting within 7 days after receipt of Notice to Proceed (NTP) and provide/submit the following documents thereat:
  - i. Implementation plan of the project in GANTT Chart form.
  - ii. Systems Documentation (installation and configuration), to include the network schematic diagram describing in detail the connection from the SP to the DOE.
  - iii. Detailed cost breakdown of various components of this TOR. (Refer to Annex C).

# V. SERVICE LEVEL AGREEMENT COVERING THE SCOPE OF WORKS AND OTHER RELATED SERVICES (Refer to Annex B)

#### VI. CONTRACT DURATION

- The Contract Period (CP) for the Fixed Wireless Connection shall cover one year (from 01 January to 31 December 2025), unless otherwise terminated by the DOE.
- 2. In case the Contract commences at a date later than 01 January 2025, the CP shall be calculated to be the remaining number of months covering the new start date up to 31 December 2025.
- 3. The CP may be extended subject to the same terms and conditions stipulated in the approved Contract; provided, however, the SP has rendered satisfactory performance; provided, further, that said extension is based on the provisions under Appendix 17 (Revised Guidelines on the Extension of Contracts for General Support Services) of the IRR of Republic Act (RA) No. 9184.
- 4. Also, Contract may be renewed subject to the provisions under Appendix 13 (Guidelines on Procurement of Water, Electricity, Telecommunications, and Internet Service Providers) of RA No. 9184.

#### VII. PAYMENT TERMS

The SP shall be paid only for services rendered. The Total Contract Price shall be divided by 12 months to calculate the Monthly Recurring Cost (MRC) and shall be the basis for the monthly payments to be received by the SP.

#### VIII. PENALTY / REBATE CLAUSE

- The SP shall exert reasonable efforts to ensure that the provided circuit is operating and available to the DOE. In the event the circuit is not available as agreed, or in the event the DOE experiences any downtime of any of the other services, the DOE shall be eligible to receive a rebate in accordance with the service credits computation in the SLA.
- 2. It is understood that the DOE shall not be entitled to a rebate if the interruptions or outages are caused by any of the following:
  - i. The DOE's equipment, or facilities including any third-party equipment other than equipment furnished by the SP as part of their access services (i.e., DOE's equipment failure, power failure),
  - ii. Interruptions during any period where the SP or its agents are not allowed access to the DOE premises where the access lines are terminated,
  - iii. Scheduled maintenance,
  - iv. Force Majeure (e.g., typhoons, lightning, flood, earthquakes, etc.), or
  - v. Civil disturbance, military insurrection and/or government takeover of Services.

#### IX. OTHER TERMS

To ensure the reliability and availability of the DOE's internet service, a SP may only be awarded one internet access service.

#### X. DELIVERY SCHEDULE

The installation and activation of the Fixed Wireless Internet connection shall be completed within 30 days upon receipt of NTP.

# ANNEX B SERVICE LEVEL AGREEMENT (SLA) FIXED WIRELESS INTERNET ACCESS

#### Introduction

This Service Level Agreement (SLA) outlines the terms, conditions, and expectations for the internet and support services provided by the Service Provider (SP) to the Department of Energy (DOE).

#### **Purpose**

The DOE depends on the internet to perform its functions.

This SLA sets out what levels of availability and support the DOE is guaranteed to receive for the internet service provision. It also explains what service credits the DOE will be entitled to should the SP fail to meet these levels.

This SLA is an integral part of the procurement Contract between the DOE and the internet SP. It aims to enable the two parties to work together effectively.

#### **Effective Date**

This SLA shall take effect at the beginning of the Contract and shall remain valid until the Contract ends on 31 December 2025, unless otherwise the procurement Contract is extended.

#### 1. Definitions

- 1.1. Service Refers to the internet access services provided by the SP, including but not limited to connectivity to the internet, bandwidth, and related services as described in this SLA.
- 1.2. Service Availability Refers to the percentage of time the Service is fully operational, excluding scheduled maintenance, force majeure events, and other exceptions described herein.
- 1.3. Downtime Refers to periods when the Service is unavailable for use due to failures or interruptions.
- 1.4. Maintenance Window Refers to a scheduled time during which the SP may conduct maintenance on the Service, during which access may be temporarily unavailable.
- 1.5. Response Time Refers to the time taken by the SP to respond to a DOE support request regarding an issue with the Service. Auto-generated email replies are not accepted as response acknowledgment.
- 1.6. Resolution Time Refers to the time taken by the SP to resolve an issue after it has been reported.
- 1.7. MRC Refers to the Monthly Recurring Cost.

#### 2. Service Performance Commitments (SPC)

2.1. Service Availability:

The SP commits to provide a minimum of 99.0% circuit availability monthly.

2.2. Uptime Calculation:

Uptime is calculated as follows:

Uptime(%) = 
$$\left(\frac{720 - \text{Downtime}}{720}\right) \times 100$$

2.3. Network Latency:

The SP commits to maintain an average network latency of less than 100ms based on ping test result, which will be monitored daily by the DOE.

2.4. Packet Loss:

- The SP guarantees that packet loss will not exceed 2% based on ping test result, which will be monitored daily by the DOE.
- 2.5. Ping tests shall be performed from the DOE's WAN switch to the SP's gateway IP address.

#### 3. Response and Resolution Times

3.1. Incident Priority Levels:

DOE-reported incidents are classified into different priority levels. Response and resolution times will vary depending on the severity of the issue:

Priority Level	Description	Response Time	Resolution Time
Critical	Service is completely down or severely degraded (e.g., no Internet access).	Within 30 minutes	
High	Significant performance issues or service degradation affecting multiple users (e.g., intermittent access, slow speeds).	Within 60 minutes	Within 130 minutes

Low	General inquiries or non-urgent issues (e.g., account changes, billing queries).	Within 2 hours	Within 72 hours

#### 3.2. Incident Response:

- 3.2.1 The SP shall acknowledge receipt of the DOE's support request within the response time defined for each priority level as defined in Clause 3.1 above.
- 3.2.2 If the SP fails to meet the response time during the Contract period, the following constitutes the service credits the DOE will be entitled to for every infraction committed by the SP:

ird infraction onwards	One day

#### 3.2.3 Escalation Process:

The matrix below shows the timeline for the SP to escalate the DOE-reported incident within their organization. The SP shall provide contact details for each level in the matrix.

• Level 1: Ticket Creation

• Level 2: 2 hours after ticket creation

• Level 3: 4 hours after ticket creation

• Level 4: 8 hours after ticket creation

#### 3.3. Incident Resolution:

If the SP fails to meet the resolution time indicated in item 3.1, the DOE shall receive service credits as provided under item 4.2 below.

#### 4. Maintenance and Downtime

#### 4.1. Scheduled Maintenance:

The SP shall notify the DOE of any scheduled maintenance at least five days in advance. 4.2. Service Credits for Non-Compliance of SPC:

If the SP does not meet the SPC, the DOE will be eligible for service credits. The service credit is calculated as follows:

#### 5. DOE Responsibilities

## 5.1. Incident Reporting:

The DOE will promptly report any service interruptions, performance issues, or other related concerns to the SP using the designated support channels (e.g., phone, email, support portal).

#### 5.2. Access to Equipment:

The DOE shall provide reasonable access to the premises or relevant equipment for troubleshooting or maintenance activities when required by the SP.

#### 5.3. Proper Use:

The DOE agrees to use the Service in accordance with the terms of this Agreement and will not engage in any activities that negatively affect the performance of the network, such as spamming or illegal activities.

#### 6. Exclusions

The following events do not constitute downtime or violations of the SLA:

- Scheduled maintenance (with prior notice).
- Force majeure events (e.g., natural disasters, government regulations, civil disturbance, military insurrection and/or government takeover of the SP's operations and facilities).
