CONTRACT AGREEMENT

THIS AGREEMENT made the ____ day of ____ 2023 between **DEPARTMENT OF ENERGY (DOE)** of the Philippines (hereinafter called "the Entity") of the one part and **TANJER ENTERPRISES** of **Unit 1104 Antel Seaview Tower Bldg., Roxas Blvd. St., Brgy. 076 Pasay City** (hereinafter called "the Service Provider") of the other part;

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as an integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract;
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of Six Hundred Forty Thousand Eight Hundred Forty-Four Pesos and Fifty Centavos Only (PhP640,844.50) or such other sums as may be ascertained, Tanjer Enterprises agrees to the Procurement of Supply and Delivery of Various Promotional Materials (Journal Notebook and Pen, Portable Digital Thermometer-Hygrometer with Clock, and PELP ID Holder Lanyard with USB 3.0 Flash Drive 16GB), in accordance with its Bid.
- 4. The **Department of Energy** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
