Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of **Seven Million Nine Hundred Fifty Thousand Pesos Only (Php7,950,000.00)** or such other sums as may be ascertained, **Beacon Solutions, Inc.** agrees to the **Enhancement of the DOE Electric Power Database Management System (DEPDMS)** in accordance with its Bid.
- 4. The **Department of Energy** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
