## (RE – BIDDING) DOE COMPUTER MAINTENANCE SERVICES FOR CY2024

- The Department of Energy (DOE) is undertaking Early Procurement Activities for the CY2024 Computer Maintenance Services and intends to apply the sum of Php3,000,000.00 that will be sourced from the FY 2024 GAA, being the Approved Budget for the Contract (ABC) to payments for the contract under Purchase Request No. 02-0101-2024-EP-0018. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The DOE now invites bids for DOE Computer Maintenance Services for CY2024. Delivery of the Goods and Services is Five (5) Days upon receipt of Notice to Proceed. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

#### Section II. Instructions to Bidders

#### 1. Scope of Bid

The Procuring Entity, Department of Energy wishes to receive Bids for the **DOE Computer Maintenance Service for CY 2024** under Purchase Request No. 02-0101-2024-EP-0018.

#### 2. Funding Information

2.1. The GOP through the source of funding from GAA for **FY2024**, in the amount of **Php3,000,000.00**.

#### 3. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manuals and associated policies, rules, and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.

Any amendments made to the IRR and other GPPB issuances shall be applicable only to the ongoing posting, advertisement, or **IB** by the BAC through the issuance of a supplemental or bid bulletin.

The Bidder, by the act of submitting its Bid, shall be deemed to have verified and accepted the general requirements of this Project, including other factors that may affect the cost, duration and execution or implementation of the contract, project, or work and examine all instructions, forms, terms, and project requirements in the Bidding Documents.

## 4. Corrupt, Fraudulent, Collusive, and Coercive Practices

The Procuring Entity, as well as the Bidders and Suppliers, shall observe the highest standard of ethics during the procurement and execution of the contract. They or through an agent shall not engage in corrupt, fraudulent, collusive, coercive, and obstructive practices defined under Annex "I" of the 2016 revised IRR of RA No. 9184 or other integrity violations in competing for the Project.

## 5. Eligible Bidders

- 5.1. Only Bids of Bidders found to be legally, technically, and financially capable will be evaluated.
- 5.2. Foreign ownership limited to those allowed under the rules may participate in this Project.
- 5.3. Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No.9184, the Bidder shall have an SLCC that is at least one (1) contract similar to the

Project the value of which, adjusted to current prices using the PSA's CPI, must be at least equivalent to at least fifty percent (50%) of the ABC.

5.4. The Bidders shall comply with the eligibility criteria under Section 23.4.1 of the 2016 IRR of RA No. 9184.

#### 6. Origin of Goods

There is no restriction on the origin of goods other than those prohibited by a decision of the UN Security Council taken under Chapter VII of the Charter of the UN, subject to Domestic Preference requirements under **ITB** Clause 18.

#### 7. Subcontracts

7.1. The Procuring Entity has prescribed that: **Subcontracting is not** allowed.

## 8. Pre-Bid Conference

The Procuring Entity will hold a pre-bid conference for this Project on the specified date and time and either at its physical address and/or through videoconferencing as indicated in paragraph 6 of the **IB**.

#### 9. Clarification and Amendment of Bidding Documents

Prospective bidders may request for clarification on and/or interpretation of any part of the Bidding Documents. Such requests must be in writing and received by the Procuring Entity, either at its given address or through electronic mail indicated in the **IB**, at least ten (10) calendar days before the deadline set for the submission and receipt of Bids.

#### 10. Documents comprising the Bid: Eligibility and Technical Components

- 10.1. The first envelope shall contain the eligibility and technical documents of the Bid as specified in Section VIII (Checklist of Technical and Financial Documents).
- 10.2. The Bidder's SLCC as indicated in **ITB** Clause 5.3 should have been completed **within two (2) years** prior to the deadline for the submission and receipt of bids.
- 10.3. If the eligibility requirements or statements, the bids, and all other documents for submission to the BAC are in foreign language other than English, it must be accompanied by a translation in English, which shall be authenticated by the appropriate Philippine foreign service establishment, post, or the equivalent office having jurisdiction over the foreign bidder's affairs in the Philippines. Similar to the required authentication above, for Contracting Parties to the Apostille Convention, only the translated documents shall be authenticated through an apostille pursuant to GPPB Resolution No. 13-2019 dated 23 May 2019.

The English translation shall govern, for purposes of interpretation of the bid.

## 11. Documents comprising the Bid: Financial Component

- 11.1. The second bid envelope shall contain the financial documents for the Bid as specified in **Section VIII (Checklist of Technical and Financial Documents)**.
- 11.2. If the Bidder claims preference as a Domestic Bidder or Domestic Entity, a certification issued by DTI shall be provided by the Bidder in accordance with Section 43.1.3 of the 2016 revised IRR of RA No. 9184.
- 11.3. Any bid exceeding the ABC indicated in paragraph 1 of the **IB** shall not be accepted.
- 11.4. For Foreign-funded Procurement, a ceiling may be applied to bid prices provided the conditions are met under Section 31.2 of the 2016 revised IRR of RA No. 9184.

#### 12. Bid Prices

- 12.1. Prices indicated on the Price Schedule is inclusive of all Value added tax and all other applicable taxes and charges and shall be entered separately in the following manner:
  - a. For Goods offered from within the Procuring Entity's country:
    - i. The price of the Goods quoted EXW (ex-works, ex-factory, exwarehouse, ex-showroom, or off-the-shelf, as applicable);
    - ii. The cost of all customs duties and sales and other taxes already paid or payable;
    - iii. The cost of transportation, insurance, and other costs incidental to delivery of the Goods to their final destination; and
    - iv. The price of other (incidental) services, if any, listed in e.
  - b. For Goods offered from abroad:
    - i. Unless otherwise stated in the BDS, the price of the Goods shall be quoted delivered duty paid (DDP) with the place of destination in the Philippines as specified in the BDS. In quoting the price, the Bidder shall be free to use transportation through carriers registered in any eligible country. Similarly, the Bidder may obtain insurance services from any eligible source country.
    - ii. The price of other (incidental) services, if any, as listed in **Section VII (Technical Specifications).**

## 13. Bid and Payment Currencies

- 13.1. For Goods that the Bidder will supply from outside the Philippines, the bid prices may be quoted in the local currency or tradeable currency accepted by the BSP at the discretion of the Bidder. However, for purposes of bid evaluation, Bids denominated in foreign currencies, shall be converted to Philippine currency based on the exchange rate as published in the BSP reference rate bulletin on the day of the bid opening.
- 13.2. Payment of the contract price shall be made in: Philippine Pesos

## 14. Bid Security

- 14.1. The Bidder shall submit a Bid Securing Declaration or any form of Bid Security in the amount indicated in the **BDS**, which shall be not less than the percentage of the ABC in accordance with the schedule in the **BDS**.
- 14.2. The Bid and bid security shall be valid **until June 2024.** Any Bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive.

## 15. Sealing and Marking of Bids

Each Bidder shall submit one copy of the first and second components of its Bid.

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.

If the Procuring Entity allows the submission of bids through online submission or any other electronic means, the Bidder shall submit an electronic copy of its Bid, which must be digitally signed. An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and, thus, automatically disqualified.

## 16. Deadline for Submission of Bids

16.1. The Bidders shall submit on the specified date and time and either at its physical address or through online submission as indicated in paragraph 7 of the **IB**.

## 17. Opening and Preliminary Examination of Bids

17.1. The BAC shall open the Bids in public at the time, on the date, and at the place specified in paragraph 9 of the **IB**. The Bidders' representatives who are present shall sign a register evidencing their attendance. In case videoconferencing, webcasting or other similar technologies will be used, attendance of participants shall likewise be recorded by the BAC Secretariat.

In case the Bids cannot be opened as scheduled due to justifiable reasons, the rescheduling requirements under Section 29 of the 2016 revised IRR of RA No. 9184 shall prevail.

17.2. The preliminary examination of bids shall be governed by Section 30 of the 2016 revised IRR of RA No. 9184.

#### **18. Domestic Preference**

18.1. The Procuring Entity will grant a margin of preference for the purpose of comparison of Bids in accordance with Section 43.1.2 of the 2016 revised IRR of RA No. 9184.

#### 19. Detailed Evaluation and Comparison of Bids

- 19.1. The Procuring BAC shall immediately conduct a detailed evaluation of all Bids rated "*passed*," using non-discretionary pass/fail criteria. The BAC shall consider the conditions in the evaluation of Bids under Section 32.2 of the 2016 revised IRR of RA No. 9184.
- 19.2. If the Project allows partial bids, bidders may submit a proposal on any of the lots or items, and evaluation will be undertaken on a per lot or item basis, as the case maybe. In this case, the Bid Security as required by ITB Clause 14 shall be submitted for each lot or item separately.
- 19.3. The descriptions of the lots or items shall be indicated in Section VII (Technical Specifications), although the ABCs of these lots or items are indicated in the BDS for purposes of the NFCC computation pursuant to Section 23.4.2.6 of the 2016 revised IRR of RA No. 9184. The NFCC must be sufficient for the total of the ABCs for all the lots or items participated in by the prospective Bidder.
- 19.4. The Project shall be awarded as One (1) Project having several items that shall be awarded as one contract.
- 19.5. Except for bidders submitting a committed Line of Credit from a Universal or Commercial Bank in lieu of its NFCC computation, all Bids must include the NFCC computation pursuant to Section 23.4.1.4 of the 2016 revised IRR of RA No. 9184, which must be sufficient for the total of the ABCs for all the lots or items participated in by the prospective Bidder. For bidders submitting the committed Line of Credit, it must be at least equal to ten percent (10%) of the ABCs for all the lots or items participated in by the prospective Bidder.

## 20. Post-Qualification

20.2. Within a non-extendible period of five (5) calendar days from receipt by the Bidder of the notice from the BAC that it submitted the Lowest Calculated Bid, the Bidder shall submit its latest income and business

tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS) and other appropriate licenses and permits required by law and stated in the **BDS**.

## 21. Signing of the Contract

21.1. The documents required in Section 37.2 of the 2016 revised IRR of RA No. 9184 shall form part of the Contract. Additional Contract documents are indicated in the **BDS**.

## **Bid Data Sheet**

## 1. Scope of Contract

This Contract shall include all such items, although not specifically mentioned, that can be reasonably inferred as being required for its completion as if such items were expressly mentioned herein. All the provisions of RA No. 9184 and its 2016 revised IRR, including the Generic Procurement Manual, and associated issuances, constitute the primary source for the terms and conditions of the Contract, and thus, applicable in contract implementation. Herein clauses shall serve as the secondary source for the terms and conditions of the Contract.

This is without prejudice to Sections 74.1 and 74.2 of the 2016 revised IRR of RA No. 9184 allowing the GPPB to amend the IRR, which shall be applied to all procurement activities, the advertisement, posting, or invitation of which were issued after the effectivity of the said amendment.

Additional requirements for the completion of this Contract shall be provided in the **Special Conditions of Contract** (**SCC**).

## 2. Advance Payment and Terms of Payment

- 2.1. Advance payment of the contract amount is provided under Annex "D" of the revised 2016 IRR of RA No. 9184.
- 2.2. The Procuring Entity is allowed to determine the terms of payment on the partial or staggered delivery of the Goods procured, provided such partial payment shall correspond to the value of the goods delivered and accepted in accordance with prevailing accounting and auditing rules and regulations. The terms of payment are indicated in the **SCC**.

## 3. Performance Security

Within ten (10) calendar days from receipt of the Notice of Award by the Bidder from the Procuring Entity but in no case later than prior to the signing of the Contract by both parties, the successful Bidder shall furnish the performance security in any of the forms prescribed in Section 39 of the 2016 revised IRR of RA No. 9184

## 4. Inspection and Tests

The Procuring Entity or its representative shall have the right to inspect and/or to test the Goods to confirm their conformity to the Project specifications at no extra cost to the Procuring Entity in accordance with the Generic Procurement Manual. In addition to tests in the **SCC**, **Section IV (Technical Specifications)** shall specify what inspections and/or tests the Procuring Entity requires, and where they are to be conducted. The Procuring Entity shall notify the Supplier in writing, in a timely manner, of the identity of any representatives retained for these purposes.

All reasonable facilities and assistance for the inspection and testing of Goods, including access to drawings and production data, shall be provided by the Supplier to the authorized inspectors at no charge to the Procuring Entity.

#### 5. Warranty

- 5.1 In order to assure that manufacturing defects shall be corrected by the Supplier, a warranty shall be required from the Supplier as provided under Section 62.1 of the 2016 revised IRR of RA No. 9184.
- 5.2 The Procuring Entity shall promptly notify the Supplier in writing of any claims arising under this warranty. Upon receipt of such notice, the Supplier shall, repair or replace the defective Goods or parts thereof without cost to the Procuring Entity, pursuant to the Generic Procurement Manual.

## 6. Liability of the Supplier

The Supplier's liability under this Contract shall be as provided by the laws of the Republic of the Philippines.

If the Supplier is a joint venture, all partners to the joint venture shall be jointly and severally liable to the Procuring Entity.

Where the Supplier is required under this Contract to transport the Goods to a specified place of destination within the Philippines, defined as the Project Site, transport to such place of destination in the Philippines, including insurance and storage, as shall be specified in this Contract, shall be arranged by the Supplier, and related costs shall be included in the contract price.

Where the Supplier is required under Contract to deliver the Goods CIF, CIP or DDP, Goods are to be transported on carriers of Philippine registry. In the event that no carrier of Philippine registry is available, Goods may be shipped by a carrier which is not of Philippine registry provided that the Supplier obtains and presents to the Procuring Entity certification to this effect from the nearest Philippine registry are available, but their schedule delays the Supplier in its performance of this Contract the period from when the Goods were first ready for shipment and the actual date of shipment the period of delay will be considered force majeure.

The Procuring Entity accepts no liability for the damage of Goods during transit other than those prescribed by INCOTERMS for DDP deliveries. In the case of Goods supplied from within the Philippines or supplied by domestic Suppliers, risk and title will not be deemed to have passed to the Procuring Entity until their receipt and final acceptance at the final destination.

## Intellectual Property Rights -

The Supplier shall indemnify the Procuring Entity against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the Goods or any part thereof.

4. Provision of detailed operational status report and recommendations for all equipment/devices maintained or serviced.

#### **B.** Remedial Services

Remedial services refer to remedial/corrective actions to be taken into isolate and correct problems encountered in the use of computer systems.

Remedial services include:

- 1. Provision of user service calls via face-to-face contact and phone in assistance in troubleshooting, diagnosing, and repairing computers and their peripherals (both hardware and software);
- 2. Provision of assistance to the DOE IT staff in the evaluation and recommendation of computer system upgrades and problem resolution for all DOE computer equipment (including those not covered in Attachment A);
- 3. Assemble and upgrade computers, as needed.

#### C. Software Support Services

Software support services refers to all software-related services the Contractor shall provide to ensure an optimized computer system and end-user productivity.

- 1. Provision of software installation, which includes computer operating system, device firmware and drivers, and office productivity applications.
- 2. Provision of assistance in acquiring and installing updates and patches for operating systems, device firmware and drivers, and office productivity applications.
- 3. Provision of assistance in using office productivity applications such as Word, Excel, PowerPoint, Outlook, etc.
- 4. Provision of on-call end-point protection software installation and update, and removal of viruses, malware, and other similar threats.

## D. Other Services

- 1. Conduct two (2) training sessions on basic PC troubleshooting and repair for the DOE employees (45 participants/training session), which shall be held at a venue designated by the DOE.
- 2. After the performance of the services, all equipment/devices should be reconnected, powered, and tested. Said equipment/devices should be fully functional at the conclusion of the test. Breakdowns or malfunctions within one week from the last service date shall remain the Contractor's responsibility and shall be remediated immediately.
- 3. Conduct a system diagnostic test after preventive maintenance and/or remedial services.
- 4. Provision of assistance in computer system relocation and set-up

when needed.

- 5. Provision of assistance to the Information Services Division (ISD) in conducting regular computer system visits/inspections to various DOE units and educating end-users on proper computer system maintenance and usage.
- 6. Conduct external cleaning of computers and peripherals as needed and/or warranted.
- 7. Check the computer workplace environment (e.g., humidity, voltage outputs, wire lay-outing, etc.).
- 8. Provision of assistance to the ISD in the conduct of the DOE ICT resources inventory update.

#### E. Service/Replacement Units

Service unit refers to a personal computer issued to an end-user as their temporary working unit when their working unit is pulled out for problem isolation or repair. On the other hand, replacement units refer to computer systems or parts which shall be used by the Contractor to replace defective computer systems or parts, either temporarily or permanently.

#### 1. <u>Computer Service Units</u>

The Contractor shall maintain three (3) working All-in-One (AIO) computers as Service Units at the ISD-CSS area of the DOE Main Office at no additional cost to the DOE, with at least Core i5 processor, 8GB RAM, 256GB SSD storage and 23" monitor display.

All service units shall remain the property of the Contractor during the entire term of the Contract.

2. Service Parts

The Contractor shall maintain an inventory of computer parts at ISD-CSS, which shall be used as service units in case needed with the following technical specifications:

- a. 3 units 8GB DDR3 1600MHz
- b. 3 units 8GB DDR4 2600MHz
- c. 5 units USB keyboard
- d. 5 units USB optical mouse
- e. 2 units 600 watts power supply

## 3. Replacement Parts

If during preventive maintenance/remedial services, it was found that the DOE's computer system/parts are defective, the Contractor shall provide the DOE with replacement parts, which shall have the same specifications or better, at no additional cost to the DOE, which shall be limited only to the following:

- a. 40 units of Random Access Memory (RAM)
  - b. 20 units of Storage Drive (HDD/SSD)
  - c. 22 units of Keyboard and Mouse
  - d. 20 units of Power Supply
  - e. 20 units of CMOS Battery

Other replacement parts not included in the above-mentioned list shall be provided by the DOE.

#### F. Manpower

Manpower refers to personnel, employees and/or workers of the Contractor who can conduct technical services (e.g., troubleshooting, repair, etc.) for DOE computer systems.

The Contractor shall provide seven (7) competent technical support personnel to provide various support services as stipulated in this TOR. Four of which shall be assigned at the DOE-Main Office and shall report 8 hours a day on a flexible schedule from 7:00 AM to 5:00 PM, and be oncall for computer service during office hours, from Monday to Friday, excluding all special and national holidays. Furthermore, three (3) of those technical support personnel shall be assigned at the DOE Field Offices (1 technician each for LFO, VFO, and MFO) and shall likewise regularly report for eight (8) hours a day on a flexible schedule from 7:00 AM to 5:00 PM, and be on-call for computer service during office hours, from Monday to Friday, excluding all special and national holidays.

- 1. The technical support personnel must meet the following qualifications:
  - Be a graduate of B.S. Computer Engineering/Computer Science or any two (2) - year Computer System/Information Technology - related course;
  - b. Have at least three (3) years actual experience (after graduation) in conducting computer preventive maintenance, troubleshooting, and repair; and
  - c. Must be TESDA Computer Systems Servicing NC II certified. In the absence of the certification, the Contractor may instead submit an undertaking to present the certification of the personnel to be assigned at the DOE within three months after the execution of the Contract.
- 2. In the absence of any one of their technical support personnel, the Contractor shall immediately assign/provide a reliever with the same skills and expertise.
- 3. All technical support personnel assigned to the DOE (Main Office and Field Offices) shall remain the Contractor's employees and shall not be replaced unless expressly approved by the ITMS Director. Upon request of the ISD Chief and approval of the ITMS Director, the Contractor shall replace any personnel assigned whom the DOE believes has not performed competently in accordance with this TOR.
- 4. All Contractor personnel shall always coordinate with the CSS Staff of ISD regarding any concerns/issues related to the efficient and effective performance of their computer maintenance services. Computer maintenance service concerns/issues encountered by the

Contractor personnel at the DOE Field Offices shall be coordinated with the designated IT counterpart of the ITMS.

- 5. All Contractor personnel shall strictly observe and abide by all applicable laws, rules and regulations such as but not limited to, the Data Privacy Act, Cybercrime Prevention Act, DOE Acceptable Usage and Security Policy, and relevant DOE office rules and regulations.
- 6. The Contractor shall provide an appropriate uniform for its personnel assigned at the DOE offices.
- 7. The DOE-ITMS may endorse its existing personnel to the Contractor for hiring.

#### G. Other Resources

Other Resources refers to all equipment, software utilities, tools, cleaning materials and other devices located in and out of the DOE premises, which the Contractor's technical personnel use to effectively accomplish preventive maintenance and remedial services.

The Contractor shall provide its personnel with the following:

- 1. Tools Computer tool set which includes precision screwdriver set and grounding wrist strap for each IT Technician, Multi-tester, vacuum/blower, etc.
- 2. Software Utilities- Hiren's Boot CD (latest version), File Recovery and other Systems Utilities.
- 3. Cleaning Materials multi-purpose cleaning solution, electronics contact cleaning solution, lint-free cloth, plastic cable ties, alcohol, etc.

#### H. Reports

The Contractor shall submit the following documents/reports to the DOE:

- 1. PM report on a semi-annual basis, countersigned by end-user.
- 2. Monthly reports on Remedial Services rendered, countersigned by the end- user.
- 3. Summary of semi-annual report for PM and monthly report for remedial service/s rendered.
- 4. Semi-annual inventory report of all DOE computer equipment and peripherals.
- 5. Other reports that the DOE may require.

The Contractor shall keep the contents of its reports strictly confidential and may not share or otherwise disclose the same to any third party without the DOE's prior written consent.

#### III. Contract Duration

The duration of the Computer Maintenance Services shall be from the start of the Contract until 31 December 2024, unless otherwise terminated by the DOE. The contract may be extended subject to the same terms and conditions stipulated in the approved Contract, provided, that the Contractor has rendered satisfactory performance, as certified by the DOE, provided further, that said extension is based on the provisions of the Government Procurement Reform Act (Republic Act No. 9184), and its implementing rules and regulations.

#### IV. Commencement of the Contract/Delivery Commencement

The Contract shall commence upon receipt by the Contractor of the Notice to Proceed. The Contractor shall commence the delivery of its services within 5 days after the commencement of the Contract.

#### V. Inception/Kickoff Meeting

Within 15 calendar days from the commencement of the Contract, the Contractor shall participate in an inception/kickoff meeting to discuss the details of the implementation of the Contract which includes the PM implementation plan, the conduct of the basic troubleshooting and repair training, and to familiarize the Contractor's technical support personnel to be assigned at the DOE with the DOE's ICT Acceptable Usage and Security Policy, among others.

#### VI. Terms of Payment

The payment of the Total Contract Price (TCP) shall be divided equally among the number of months of the contract duration. The Contractor shall bill the DOE for services rendered on a monthly basis.

  - iv. Supplemental or Bid Bulletins, if any
  - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information <u>prescribed</u> by the GPPB that are subsequently required for submission after

the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
