Reference standard will be used to check the equipment's performance. The equipment will be turned over to the end user after signing the acceptance report.
- 5. Maintenance shall be carried out during the DOE's normal business hours, or at such other times as agreed upon between the service contractor and the end user.
- 6. No amount shall be charged to the customer if the unit is not repaired due to unavailability of part/s.
