A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT THROUGH THE USE OF ALTERNATIVE MODE OF PROCUREMENT (AMP), FOR THE PROCUREMENT OF VENUE, MEALS, AND ACCOMMODATION FOR THE CONDUCT OF PUBLIC CONSULTATION ON THE PROPOSED DEPARTMENT CIRCULAR ON THE GUIDELINES ON COAL TRADING, TRANSPORT, STORAGE, DISTRIBUTION AND UTILIZATION IN THE PHILIPPINES

WHEREAS, the Bids and Awards Committee (BAC) received a memorandum dated 14 September 2023 from Dir. Nenito C. Jariel, Jr. of the Energy Resource Development Bureau (ERDB) requesting the BAC's approval through the use of AMP for the Procurement of Venue, Meals, and Accommodation for the Conduct of Public Consultation on the Proposed Department Circular on the Guidelines on Coal Trading, Transport, Storage, Distribution and Utilization in the Philippines with an approved budget for the contract in the amount of Six Hundred Sixty-Five Thousand Two Hundred Pesos Only (Php665,200.00);

WHEREAS, this procurement has been included in the Department's CY 2023 Supplemental Annual Procurement Plan No. 3 approved by the Secretary Raphael P. M. Lotilla;

WHEREAS, Sections 48.1, 53 and 53.10 Rule XVI of the 2016 Revised IRR of Republic Act (RA) No. 9184 authorized the conduct of Negotiated Procurement under the AMP, the pertinent provisions of which are quoted as follows:

"Sec. 48.1 Alternative Methods. — Subject to the prior approval of the Head of the Procuring Entity, and whenever justified by the conditions provided in this Act, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement provided in this Rule. In all instances, the procuring entity shall ensure that the most advantageous price for the Government is obtained:

"Sec. 53. Negotiated Procurement is a method of procurement of goods, infrastructure projects and consulting services whereby the procuring entity directly negotiates a contract with a technically, legally, and financially capable supplier, contractor or consultant only in the following cases;

"Sec. 53.10. Lease of Real Property and Venue. Lease of real property and venue for official use, subject to Annex "H" of this IRR."
