- A. Early Procurement for the Supply, Delivery and Testing and Provision of Training for Scientific Equipment: Four (4) Units Karl Fischer Titrator
  - 1. Technical Specifications
    - Compliant to ASTM D6304
    - Measurement range at least; 10 ppm-25,000 ppm
    - LOD ≤10 ppm
    - Capable as stand-alone equipment
    - Built in magnetic stirrer
    - <6kg weight</p>
    - Can be operated with use of both main power supply and portable battery

Main Power Supply: 220-240 V, 60 hertz

- Provision of one (1) portable battery for each unit (power bank/portable power supply capable of 30 minutes minimum operation).
- Reagent contact-free operation The equipment operation can be conducted without direct-contact handling of reagents and chemicals.
   All chemicals/reagents should be in a closed containers which can be use without manual mixing/preparation during the conduct of analysis.

       One (1) Year GSIS Insurance and three (3) years LTO Red Plate Registration
    - b. Warranty/Aftersales
      - 1. Vehicle warranty of (3) years or 100kms travel distance whichever comes first which shall commence upon signing of Acceptance Certificate. Supplier should warrant that all vehicle, components and accessories are new, according to the specifications and free from defects, and warranties cover the following: cab, chassis, suspension, engine, powertrain, brake and electrical systems and its accessories. The defects, if any, shall be rectified or replaced free of charge.
      - 2. Free labor for 1000 and 5000 km preventive maintenance
