2. Payment Term/Schedule
The terms of payment shall be as follows:

100% of the contract price shall be paid upon complete delivery as certified by the end-user, issuance of end-user's acceptance certificate and submission of complete documents. Payment is through List of Due and Demandable Accounts Payable - Advice to Debit Account (LDDAP-ADA) and subject to usual government budgeting, auditing and accounting procedures.

5% of the Total Contract Price shall be collected as retention for warranty which shall be released upon the completion of the warranty period.
