 - 1. Clarification on Other Terms and Conditions Item B:
 - "The bidder must provide a copy of the certificate of distributorship or Undertaking Agreement with an accredited supplier for the items for **this** procurement"

Clarification:

Submission requirements in case the bidder is a product vendor only:

- 1. Certificate of the authorized product distributor and
- 2. A notarized undertaking/agreement with the accredited distributor that in case of contract award the product vendor will source the specific product under this procurement from the said accredited distributor.
- 2. Single Largest Completed Contract (SLCC)
 - a. The coverage period for SLCC is increased from two (2) years to three (3) years.



B. Procurement of Services for the Conduct of the 2023 Energy Efficiency (EEE) Awards

1. Clarification on the amount required for the Single Largest Completed Contract (SLCC)

The Bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA's CPI, must be at least equivalent to at least fifty percent (50%) of the ABC, or at least two (2) contract similar to the Project with an aggregate value of least fifty percent (50%) of the ABC, provided the largest of these similar contracts must be equivalent to at least 25% of the ABC.
