- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of *Two Million Four Hundred Ninety Thousand Pesos Only (PhP2,490,000.00)* or such other sums as may be ascertained, ZENSHIN SYSTEMS CORPORATION agrees to the Web Access Security Isolation System with Maintenance and Support Services for One (1) Year, in accordance with its Bid.
- 4. The **Department of Energy** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
