- In consideration for the sum of Seven Million Seven Hundred Eighty-Five Thousand Eight Hundred Forty-Three Pesos and Forty Two Centavos Only (Php7,785,843.42) or USD133,653.37 @ Php58.254 / 1 USD or such other sums as may be ascertained, DUG Technology (Australia) Pty. Ltd. agrees to the Supply, Delivery and Installation of ERDB's ICT Software (Seismic Interpretation Software) for CY2024 in accordance with its Bid.
- 4. The *Department of Energy* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
