Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of *Three Million Four Hundred Eighty Thousand One Hundred Ninety Pesos Only (Php3,480,190.00)* or such other sums as may be ascertained, **Dynalab Corporation** agrees to the **Supply, Delivery, Installation and Commissioning of One Lot Oxidation Stability Tester Rancimat (Biodiesel)** in accordance with its Bid.
- 4. The **Department of Energy** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
