- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of One Million Nine Hundred Ninety-Five Thousand Pesos Only (Php1,995,000.00) or such other sums as may be ascertained, Master's Stewards Information Technology Solutions, Inc. agrees to the Supply and Delivery of Office Equipment Fourteen (14) Units Explosion Proof Digital Camera with Suitcase for CY 2024 in accordance with its Bid.
