A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT THROUGH THE USE OF ALTERNATIVE METHOD OF PROCUREMENT FOR THE OPENING OF PRE-DETERMINED AREA (PDA) APPLICATION DOCUMENTS UNDER THE 1ST BARMM CONVENTIONAL ENERGY BID ROUND AND 2024 PHILIPPINE BID ROUND

WHEREAS, the Bids and Awards Committee (BAC) received a Memorandum, dated 19 August 2024, from Dir. Nenito C. Jariel, Jr. of the Energy Resource Development Bureau (ERDB), requesting the BAC's approval through the use of Alternative Method of Procurement (AMP) – in particular, Negotiated Procurement-Lease of Real Property and Venue for Official Use, for the Procurement of Venue, Meals, and Accommodation for the Opening of Pre-Determined Area (PDA) Application Documents under the 1st BARMM Conventional Energy Bid Round and 2024 Philippine Bid Round, with an approved budget for the contract (ABC) in the amount of PhP2,350,000.00

WHEREAS, this procurement was included in the Department's CY 2024 Supplemental Annual Procurement Plan No. 4 (SAPP 4), approved by the Head of Procuring Entity;

WHEREAS, Sections 48.1, 53 & 53.10, Rule XVI of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184 authorized the conduct of AMP, the pertinent provisions of which are quoted as follows:

"Sec. 48.1 Alternative Methods. — Subject to the prior approval of the Head of the Procuring Entity, and whenever justified by the conditions provided in this Act, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement provided in this Rule. In all instances, the procuring entity shall ensure that the most advantageous price for the Government is obtained:

Sec. 53. Negotiated Procurement is a method of procurement of goods, infrastructure projects and consulting services whereby the procuring entity directly negotiates a contract with a technically, legally, and financially capable supplier, contractor or consultant only in the following cases;

Section 53.10. Lease of Real Property and Venue. Lease of real property and venue for official use, subject to Annex "H": of this IRR."

WHEREAS, New World Makati, Crown Plaza Manila Galleria, New Coast Hotel and Fairmont Makati were not available on the requested dates as confirmed by their representatives through electronic email. While Hilton Manila submitted a bid, above ABC.

WHEREAS, the BAC Technical Working Group (TWG) presented to the BAC, during its Special BAC Meeting No. 6 on 20 August 2024, the results of their evaluation, citing that the said procurement complies with the requirement of R.A. 9184, particularly the AMP- Negotiated Procurement, Lease of Real Property and Venue for Official Use, and endorsed the award of contract to **Dusit Thani Manila** for being the **Single Calculated Responsive Bidder**;

NOW, THEREFORE, in view of the foregoing, and upon motion duly made by <u>Asst. Dir. D. F. Antiporda,</u> the proponent of the activity, the BAC has resolved, as hereby it is, **RESOLVED** to:

 APPROVE the BAC-TWG findings and recommendation for the award of contract for the Procurement of Venue, Meals, and Accommodation for the Opening of Pre-Determined Area (PDA) Application Documents under the 1st BARMM Conventional Energy Bid Round and 2024 Philippine Bid Round to Dusit Thani Manila, in the amount of Two Million Three Hundred Twenty Thousand Three Hundred Pesos Only (Php2,320,300.00);

- 2. **RECOMMEND** to the Head of Procuring Entity, the approval of the award of the above-mentioned contracts; and,
- 3. **FURNISH** the Commission on Audit (COA), for its information and reference, a copy of this Resolution immediately after its approval by the Head of Procuring Entity;
