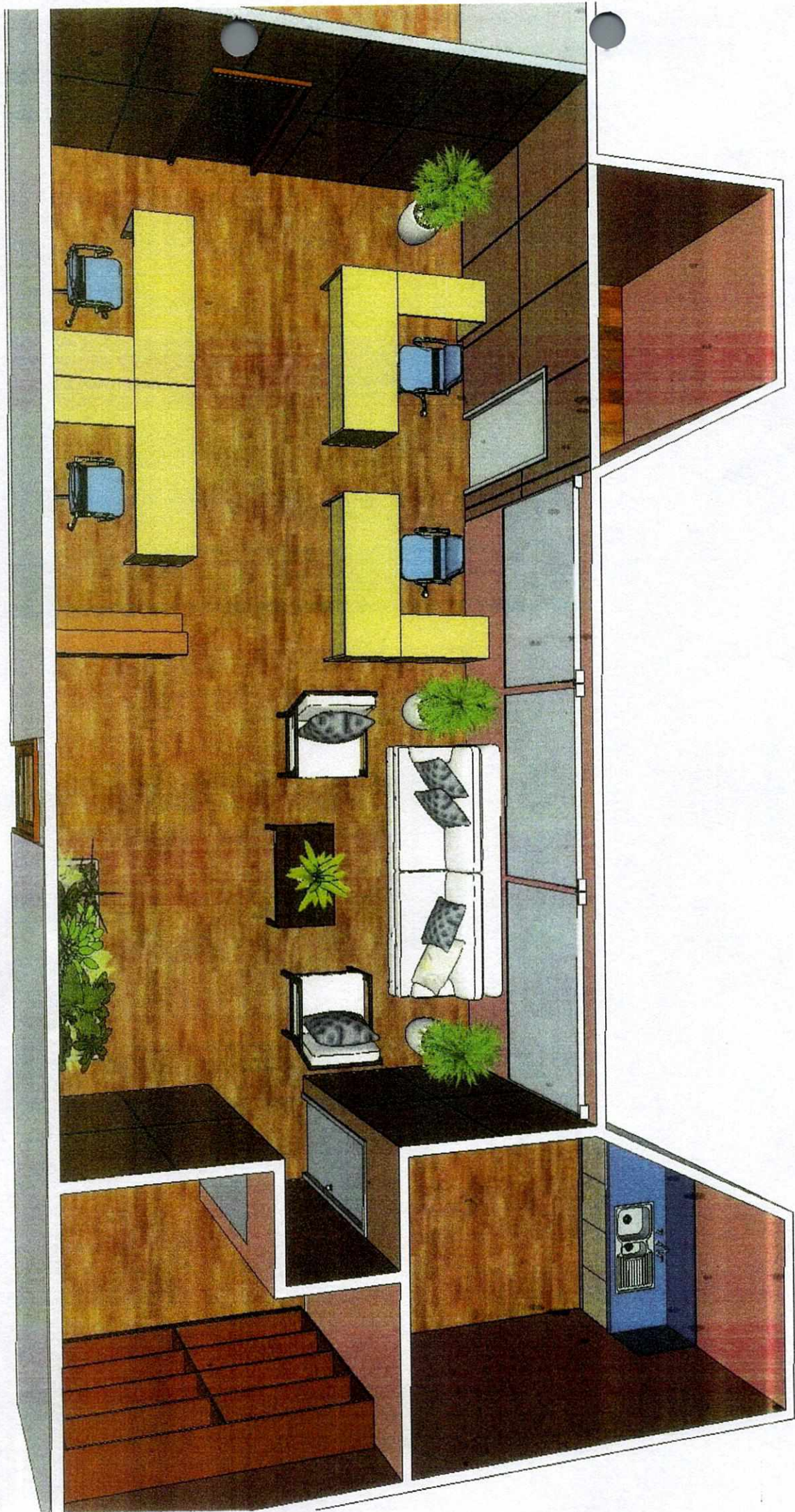

AFFIDAVIT
