**A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT
THROUGH PUBLIC BIDDING FOR THE PROCUREMENT OF
PROFESSIONAL SERVICES FOR THE UPDATING OF THE PHILIPPINE
COMPREHENSIVE ROADMAP FOR ELECTRIC VEHICLE (CREVI) 2024**

WHEREAS, the Bids and Awards Committee (BAC) conducted a Competitive Bidding, particularly Public Bidding, for the Procurement of Professional Services for the Updating of the Philippine Comprehensive Roadmap for Electric Vehicle (CREVI) 2024, with an approved budget for the contract (ABC) in the amount of PhP 2,000,000.00;

WHEREAS, this procurement was included in the Department's CY 2024 Annual Procurement Plan (APP), duly approved by Secretary Raphael P. M. Lotilla;

WHEREAS, the pre-procurement conference was conducted during the BAC Regular Meeting No. 09 on 21 March 2024, and was approved for posting on the websites of DOE and PhilGEPS, through Public Bidding, by the BAC;

WHEREAS, the Invitation to Bid was posted continuously on the websites of DOE and PhilGEPS, from 05 April 2024 to 02 May 2024, as required under Section 21, Rule VII of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A) 9184;

WHEREAS, the Pre-Bid Conference was conducted on 18 April 2024, and two (2) prospective bidders participated in the proceedings;

WHEREAS, the opening of the Technical Proposals, including the Eligibility Requirements and Financial Proposals, was held on 02 May 2024;

WHEREAS, two (2) bidders submitted its Technical Proposals, including the Eligibility Requirements and Financial Proposals where in WWC Yellow Bumblebee Corporation submitted the lowest calculated bid in the amount of PhP 1,222,777.00, details as follows;

1. **APPROVE** the BAC-TWG findings and recommendation for the award of contract for the Procurement of Professional Services for the Updating of the Philippine Comprehensive Roadmap for Electric Vehicle (CREVI) to the **WWC YELLOW BUMBLEBEE CORPORATION** in the amount of **One Million Two Hundred Twenty-Two Thousand Seven Hundred Seventy-Seven Pesos Only (PhP 1,222,777.00)**.
2. **RECOMMEND** to the Head of Procuring Entity, the approval of the award of the above-mentioned contract; and,
3. **FURNISH** the Commission on Audit (COA), for its information and reference, a copy of this Resolution immediately after its approval by the Head of Procuring Entity;
