A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT THROUGH PUBLIC BIDDING FOR THE PROCUREMENT FOR THE SUPPLY, DELIVERY AND INSTALLATION OF VARIOUS ICT SOFTWARE SUBSCRIPTION UNDER NATIONAL ENERGY EFFICIENCY AND CONSERVATION PROGRAM (NEECP) AND ALTERNATIVE FUELS FOR TRANSPORT AND OTHER PURPOSES (AFTOP)

WHEREAS, the Bids and Awards Committee (BAC) conducted a Competitive Bidding, particularly Public Bidding for the Procurement for the Supply, Delivery and Installation of Various ICT Software Subscription under NEECP and AFTOP with an approved budget for the contract (ABC) in the amount of Php5,319,000.00;

WHEREAS, this procurement was included in the Department's CY 2024 Annual Procurement Plan duly approved by Secretary Raphael P.M. Lotilla;

WHEREAS, the pre-procurement conference was conducted during the Regular Meeting No. 09 on 21 March 2024 and was approved for posting in the websites of DOE and PhilGEPS through Public Bidding by the BAC;

WHEREAS, the Invitation to Bid was re-posted continuously in the websites of DOE and PhilGEPS from 18 April – 09 May 2024, as required under Section 21, Rule VII of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A) 9184;

WHEREAS, the Pre-Bid Conference was conducted on 25 April 2024 and two (2) prospective bidders participated in the proceedings;

WHEREAS, the opening of the Technical Proposals including the Eligibility Requirements and Financial Proposals was held on 09 May 2024;

WHEREAS, two (2) bidders submitted Technical Proposals including the Eligibility Requirements and Financial Proposals, wherein Challenge Systems, Inc. submitted the lowest calculated bid in the amount of Php4,600,000.00, details as follows:
