**Resolution No. 212 s. 2024**

**A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT THROUGH  
THE USE OF ALTERNATIVE METHOD OF PROCUREMENT (AMP) –  
PARTICULARLY HIGHLY TECHNICAL CONSULTANT FOR THE  
CONSULTANCY SERVICES FOR THE PHILIPPINE CONVENTIONAL ENERGY  
CONTRACTING PROGRAM (PCECP)**

**WHEREAS**, the Bids and Awards Committee (BAC) received a Memorandum dated 22 April 2024 from Director Nenito C. Jariel Jr. of the Energy Resource Development Bureau (ERDB) requesting the BAC's approval through the use of Alternative Method of Procurement (AMP) – Highly Technical Consultant for the Procurement of Consultancy Services for the Philippine Energy Contracting Program (PCECP) with an approved budget of the contract in the amount of Php900,000.00;

**WHEREAS**, this procurement was included in the Department's CY2024 Supplemental Annual Procurement Plan No. 1 approved by the Secretary Raphael P. M. Lotilla;

**WHEREAS**, Section 48.1, 53 and 53.7 Rule XVI of the 2016 Revised IRR of R.A. 9184 authorized the conduct of AMP, the pertinent provisions of which are quoted as follows:

*"Sec 48.1 Alternative Methods – Subject to the prior approval of the Head of Procuring Entity (HoPE), and whenever justified by the conditions provided by this Act, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement provided in this Rule. In all instances, the Procuring Entity shall ensure that the most advantageous price for the Government is obtained:*

*"Sec. 53. Negotiated Procurement is a method of procurement of goods, infrastructure projects and consulting services whereby the procuring entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant only in the following cases:*

*Xxx*

*Section 53.7 Highly Technical Consultants. In case of individual consultants hired to do work the is (i) highly technical or propriety; or (ii) primarily confidential or policy determining, where trust and confidence are the primary consideration for the hiring of consultant: Provided, however, that the term of the individual consultants shall, at the most, be on six month basis, renewable at the option of the appointing HOPE, but in no case shall exceed the term of the latter.*

**WHEREAS**, Mr. Generoso P. Revilla has extensive experience in both technical and management aspects in the Upstream Petroleum industry, having worked in both the DOE and PNOC-EC in his career as a geoscientist and exploration manager. Mr. Revilla has broad know-how in petroleum exploration, development and production as well as in handling petroleum datasets and information. Moreover, Mr. Revilla is highly regarded in the upstream petroleum industry in the country, having been involved in numerous petroleum projects during his tenure in the DOE and PNOC-EC;

**WHEREAS**, the end-user had complied with the selection and requirements pursuant to the hiring of Highly Technical Consultants, wherein, Mr. Generoso P. Revilla possesses the technical skills, expertise and experience needed to carry out;
