A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT THROUGH PUBLIC BIDDING FOR THE PROCUREMENT OF SERVICES FOR THE CONCEPT, LAY-OUT DESIGN, PRINTING AND BINDING OF ENERGY SITUATIONER AND RELATED MATERIALS

WHEREAS, the Bids and Awards Committee (BAC) conducted a Competitive Bidding, particularly Public Bidding for the Procurement of Services for the Concept, Lay-Out Design, Printing and Binding of the Energy Situationer and Related Materials with an approved budget for the contract (ABC) in the amount of Php875,000.00;

WHEREAS, this procurement has been included in the Department's CY 2023 Annual Procurement Plan duly approved by the Secretary Raphael P. M. Lotilla;

WHEREAS, the Invitation to Bid was posted continuously in the website of DOE & PhilGEPS from 17 August to 07 September 2023 as required under Section 21, Rule VII of the 2016 Revised Implementing Rules & Regulation (IRR) of Republic Act (R.A.) 9184;

WHEREAS, the opening of the Technical Proposals including the Eligibility Requirements and Financial Proposals was held on 17 September 2023;

WHEREAS, a single (1) bidder submitted Technical Proposal including the Eligibility Requirements and Financial Proposal, wherein New Age Graphics, Inc. submitted a bid of Php775,000.00;

WHEREAS, the post qualification evaluation of New Age Graphics, Inc. was conducted by the BAC-TWG on 19 September 2023;

WHEREAS, based on the result of the post-qualification submitted by the BAC-TWG as indicated in the attached summary and adopted by the BAC in its Regular BAC Meeting No. 36 on 05 October 2023, the award of contract to New Age Graphics, Inc. for being the Single Calculated and Responsive Bidder is hereby recommended;

NOW, THEREFORE, in view of the foregoing, and upon motion duly made by ERDB-PFRD Chief, Mr. Danilo V. Vivar, the authorized representative of the requesting bureau, the BAC has resolved, as hereby it is, RESOLVED to:

- APPROVE the BAC-TWG findings and recommendation for the award of contract for the Procurement of Services for the Concept, Lay-Out Design, Printing and Binding of the Energy Situationer and Related Materials to New Age Graphics, Inc. in the amount of Seven Hundred Seventy-Five Thousand Pesos Only (Php775,000.00);
- RECOMMEND to the Head of Procuring Entity, the approval of the award of the above-mentioned contract; and,

3. FURNISH the Commission on Audit, for its information and reference, a copy of this Resolution immediately after its approval by the Head of Procuring Entity;
