<b>I. BACKGROUND</b> The <b>Department of Energy (DOE)</b> , hereunto referred to as the <b>CLIENT</b> , needs the services of a duly licensed/registered, capable, competent, and stable training provider which specializes in Public Speaking and Effective Presentation, hereunto referred to as the <b>Service Provider</b> , shall provide immediate intervention to our employees to develop the presentation skill and provide practical tips on how to become a more effective presenter for internal and external clients.				220,000.00

SCOPE OF WORK / BRIEF DESCRIPTION OF THE ASSIGNMENT</b> a) The <b>Service Provider</b> will design a specialized public speaking and presentation skills program for the DOE employees that conduct IECs, to increase their knowledge about the different principles of communication and effective presentation skills, to demonstrate their improved skills in public speaking, and to display their newly learned behaviors as effective communicators. b) The <b>Service Provider</b> through the workshop will likewise help the learners apply and align their new learnings on their assigned tasks to help further improve their performance as a presenter. c) The <b>Service Provider</b> will conduct two (2) sessions of PSEP for 20 employees for a sixteen (16) hour face to face session. d) The <b>Service Provider</b> will design and conduct a program to help participants to further develop the presentation skill of the employees of the Department, and to provide practical tips on how to become a more effective presenter for internal and external clients.

- f) Provide training materials and organize other necessary arrangements for the participants to attend the training.
- g) Prepare and submit the training reports for the program with Training Certificates and photographs of the participants.
- h) Submit the final training documents (manual and power point slides, group work exercise etc.) and documentation.
