#### 2.) Approved Budget for Contract

- e. Prices quoted shall be firm and irrevocable and not subject to any change whatsoever, even due to increase in cost of raw materials components and fluctuations in foreign change rates and excise duties.
- f. Supplier should warrant that all items are of first quality and in accordance to specifications and shall be free from defects. If any of the items is found defective, a replacement is necessary within three (3) weeks period upon delivery.

- g. Payment will be released within the minimum from acceptance of DOE-EPPB and upon completion of the delivery on all items and issuance of certificate of acceptance from the end user.
- h. Bid price must cover all cost such as freight, brokerage, duties, taxes, etc. attendant to the delivery of the items at Supply and Property Management Division (SPMD), Main building of DOE.



#### AFFIDAVIT
