  - Pulldown and overhaul power steering assembly
    - a. Power steering kit
    - b. Steering boots
  - o Remove and replace suspension arm bushing:
    - a. Suspension bushing upper (4pcs)
    - b. Suspension bushing lower (2pcs)
  - o Pulldown and replace front and rear shock absorber.
    - a. Front shock absorber, both sides
