 - a. Registration of the web domain (www.investmentforum.doetalks.ph or www.investmentforum.doetalks.com) whichever is available upon registration.
 - b. Develop and design a Virtual Venue with the following features:
 - i. Landing page of the event
 - ii. Virtual event lobby to show the following:
 - Event Program
 - LED Wall which contains the Event Name
 - Photobooth
 - Downloadable files of the presentations and other references
 - Feedback Form to avail of the presentations during the event
 - iii. Lobby music while waiting for the event to start
 - iv. Main Hall (Embedded Livestream) with chat features for the participants to type in their questions during the Open Forum
 - v. Helpdesk to guide and answer the participants queries on the event
 - c. Develop creatives for user interface and 360-degree environment
 - d. Provide live support during the event day
