AFFIDAVIT

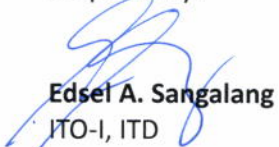

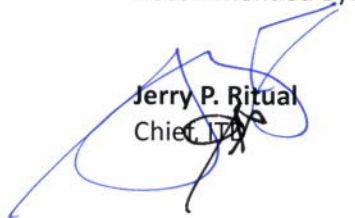

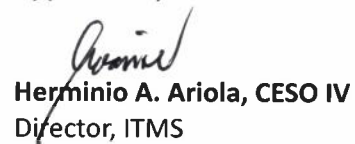
