3. ITB 12 Contents of Bid	 Audited Financial Statement (AFS) must be stamped "received" by the BIR. Mere certification from the Secretary's Certificate is NOT sufficient.
4. ITB 14 – Bid Security	The amount must be equivalent to one-year contract cost of the proposed power supply agreement computed using the bid price offered by the bidder
5. ITB 15 – Submission of Bids	On or before 10AM on the scheduled submission and opening of bids, Bid Documents

must be submitted to the TPBAC Secretary. Failure to do so, deemed disqualified. 6.
