The Pre-Bid Conference will be held on February 24, 2021, Wednesday at nine o'clock in the morning (9:00 AM) via ZOOM.

THESE MUST BE OBSERVED BEFORE THE START OF THE PRE-BID CONFERENCE:

- 1. The TPBAC will be hosting the conference, and the Bidders are allowed to enroll only one (1) authorized representative. Bidders shall be allowed additional two (2) participants as Observers **but will not have speaking privileges**.
- 2. Bidders shall confirm their attendance by submitting a Secretary's Certificate with corresponding scanned copies of two (2) valid IDs (company-issued and government-issued IDs) to the TPBAC Secretariat through email at omecocsp2018@gmail.com two (2) days prior to the scheduled pre-bid conference. This will only apply to newly authorized representative of the Bidder.
- 3. The ZOOM Meeting ID Number and Password will be sent through Bidders' official email address a day before the scheduled pre-bid conference.

To ensure the transparency of the bidding process, Observers are invited to join the Zoom virtual conference. Observers shall confirm their attendance on or before 12:00 PM of February 23, 2021. The Meeting ID and Password will be provided upon confirmation of their attendance. The public may also witness the pre-bid conference via Facebook Live by accessing the official Facebook page of OMECO IEC and OMECO CSPNEWS.

- 4. Bidders and Observers shall join the meeting 1 hour (standby mode in the waiting room) before the start of the pre-bid conference.
- 5. Bidders must test their speakers and microphones before entering the conference.
- Bidders and Observers are required to enter in the meeting with a Company/Agency_Full Name of Representative (e.g. OMECO_Juan Dela Cruz).
- 7. The pre-bid conference will start at exactly 9:00 AM but the TPBAC may still accept incoming participants during the proceedings.

THESE MUST BE OBSERVED DURING THE PROCEEDINGS OF THE PRE-BID CONFERENCE:

1. Bidders and Observers are automatically muted as they join in the pre-bid conference and shall not unmute themselves unless permitted by the TPBAC in order to avoid distracting noises.



3. Bidders and Observers must position the camera properly. Be sure it is in a stable position and focused at eye level in order to create more direct sense of commitment with the discussion and other participants.

will cause a distraction, he/she must disable his/her video.

4. We might experience internet disruptions, hence, if the TPBAC **got** disconnected, Bidders and Observers must wait for the TPBAC to re-enter the Meeting Room.

If there will be unstable connection, experiencing lagging or skipping, the Bidders and Observers must disable their video and will enable video only for the presenter (TPBAC).

- 5. During the open forum, if a Bidder wants to raise a concern/question/clarification, he/she can click the Raise Hand function in the ZOOM (Click on the icon labelled "Participants" at the bottom center of your PC or screen. At the bottom of the window on the right side of the screen, click the button labelled "Raise Hand.").
- 6. If a Bidder is being recognized, he/she must enable his/her video, and must state his/her name, designation and the company he/she representing.
- 7. Bidders are allowed only for a maximum of three (3) questions. Follow-up questions will be entertained after all other bidders are given opportunity to raise their questions.

After the TPBAC answered the concerns of the Bidder, the Bidder must disable again his/her video.

8. CSP Observers shall not participate in the proceedings and have no right to vote.
