APPLICATION

COMES NOW APPLICANT, by the undersigned counsel and to this
Honorable Commission respectfully states that:

1. It is an electric cooperative organized and existing under the laws
of the Republic of the Philippines, and is duly authorized to operate
the electric light, heat and power system in
_____ ;
2. In compliance with Section 60 of Republic Act No. 9136 (R.A.
9136), and Executive Order No. 119 (EO 119), applicant proposes
to reduce its rates commensurate with the resulting savings due to
the removal of the amortization payments of loans assumed by the

Power Sector Assets and Liabilities Management Corporation (PSALM). The proposed rate is hereto attached as Annex “B”;

3. Applicant hereby submits Schedules “A” and “B” hereto attached as Annex “A”, and other supporting documents which contain the data and calculations needed to determine the level of rate reduction in accordance with the guidelines adopted by the Energy Regulatory Commission (ERC);
4. In support of its prayer for provisional approval of the rate, applicant submits an Affidavit executed by _____, attesting to the veracity of the data and information, the correctness of the calculations, and compliance with all terms and conditions set forth in guidelines adopted by the ERC; and
5. In compliance with the provisions of Section 2, Article 3 of the ERC’s “Guidelines for the Implementation of the Reduction in Rate of the Electric Cooperatives Due to the Condonation of Debts”, the applicant has attached the certification of the receipt by the LGU Legislative Body of _____ of a copy of the application together with the certification of the notice of publication thereof in a newspaper of general circulation in the same locality.

PRAYER

WHEREFORE, Applicant respectfully prays that the attached rate (Annex "B") be provisionally and immediately approved *ex-parte*; that Applicant be authorized to adopt and implement them effective upon such provisional approval; and, after hearing, that the rate be approved permanently.

Applicant likewise prays for such other and further relief as may be deemed just and equitable in the premises.
