AMENDMENT TO SPECIAL ORDER NO. SO2017-10-0056 AND DEPARTMENT ORDER DO2017-04-0005

In the exigency of the service, the assignment of responsibilities in the Department as stated in Special Order No. SO2017-10-0056, dated 27 October 2017, is hereby modified to incorporate the establishment of the DOE-Executive Committee and ensure the effective and efficient supervision of the Bureaus, Services, Offices and monitoring of DOE-Attached and Related Agencies, and Department Order No. DO2017-04-0005, dated 07 April 2017, is hereby amended as follows:

SECTION 1. Executive Committee

An Executive Committee in the Department of Energy (hereinafter referred to as the EXECOM) is hereby established to ensure that the strategic/special programs, projects, and activities (SPPA) according to the roadmaps and directives approved by the Secretary of Energy covering energy policy and planning, energy resource development, oil industry management, electric power industry, renewable energy management and energy utilization management are implemented continuously, smoothly, efficiently, and effectively.

It shall exercise administrative and functional oversight of the DOE Management Committee and all Bureaus and Support Services of the DOE.

The EXECOM shall be composed of all Department of Energy Undersecretaries, Assistant Secretaries, Head Executive Assistant and Director Cesar G. dela Fuente, III, who shall also be its Secretariat.

SECTION 2. Authority and Functions of the EXECOM

The EXECOM shall perform and act, by majority vote of all its members, on such specific matters not otherwise within the exclusive authority of the Secretary of Energy and as may be delegated to it by the Secretary of Energy, such as:

- Manage the implementation and execution of the SPPA according to the roadmaps and directives approved by the Secretary of Energy and oversee and monitor all activities related thereto;
- b. Call upon any official and employee of the Department of Energy or any national agency or instrumentality attached or related to the Department of Energy for any assistance that may be necessary to carry out the purposes of this Special Order and to implement the aforesaid SPPA;

- c. Recommend to the Secretary of Energy any necessary and proper modifications or improvements to the aforesaid SPPA to ensure their successful implementation:
- d. Issue implementing rules and instructions to the Bureaus and Support Services of the Department of Energy necessary and appropriate to effectively execute the aforesaid SPPA; and
- e. Submit periodic reports to the Secretary of Energy for his information, review and further directions on the implementation of SPPA.

SECTION 3. Assignment of the Senior Undersecretary JESUS P. POSADAS

Senior Undersecretary JESUS P. POSADAS will act as the Chair of the EXECOM and shall supervise its day-to-day administrative functions and exercise overall supervision over all Bureaus, Services and Offices.

SECTION 4. Amendment to the Assignment of Undersecretary PETRONILO L. ILAGAN

Undersecretary Petronilo L. Ilagan shall be assigned with the responsibility of managing the Department's concerns in the Energy Regulatory Commission in addition to his assignment as the supervising Undersecretary of the Consumer Welfare and Promotions Office (CWPO).

SECTION 5. Amendment to the Assignment of Undersecretary FELIX WILLIAM B. FUENTEBELLA

In addition to Undersecretary Felix William B. Fuentebella's assignment under Special Order No. SO2017-10-0056, he shall be assigned with the responsibility of handling Philippine Electricity Market Corporation (PEMC) matters/concerns.

SECTION 6. Amendment to the Assignment of Assistant Secretary ROBERT B. UY

Assistant Secretary Robert B. Uy shall be the supervising Assistant Secretary of the Energy Policy and Planning Bureau (EPPB) and Energy Utilization and Management Bureau (EUMB) and the Investment Promotions office (IPO).

SECTION 7. Amendment to the Assignment of Assistant Secretary GERARDO D. ERGUIZA, JR.

Assistant Secretary Gerardo D. Erguiza, Jr. shall be the supervising Assistant Secretary of the Administrative Service (AS), Financial Service (FS) and Internal Audit Division.

SECTION 8. Amendment to the Assignment of Assistant Secretary CARON AICITEL E. LASCANO

In addition to her assignment as the supervising Assistant Secretary of the Renewable Energy Management Bureau (REMB) and Legal Services, Assistant Secretary Caron Aicitel E. Lascano shall be the Secretary's authorized representative and shall handle all matters pertaining to the National Renewable Energy Board (NREB).

SECTION 9. Amendment to Department Order No. DO2017-04-0005 dated 7 April 2017

The Chairperson of the Renewable Energy Contract Review and Evaluation Committee (RE-REC) as provided for under Section 5 of DO2017-04-0005 shall be the Assistant Secretary for REMB.

SECTION 10. Separability Clause

All other provisions and assignment of responsibilities contained in Special Order No. SO2017-10-0056 and Department Order No. DO2017-04-0005 not modified by nor inconsistent with this Department Order are hereby retained.

SECTION 11. Effectivity

This Order shall take effect immediately upon approval and shall remain in full force and effect until revoked by the undersigned and/or competent authority.
