AMENDMENT TO DEPARTMENT ORDER NO. <u>DO2014-02-0005</u> "CREATING A PROJECT STEERING COMMITTEE AND A PROJECT MANAGEMENT UNIT IN THE DEPARTMENT OF ENERGY FOR THE IMPLEMENTATION OF THE MARKET TRANSFORMATION THROUGH INTRODUCTION OF ENERGY-EFFICIENT ELECTRIC VEHICLES PROJECT"

WHEREAS, in view of the change of assignment and responsibilities in the Department as per Special Order No. SO2014-06-0017 and Special Order No. SO2014-06-0020;

WHEREAS, to be consistent with the said issuances, there is a need to amend DO2014-02-0005 "Creating A Project Steering Committee and a Project Management Unit in the Department of Energy for the Implementation of the "Market Transformation through Introduction of Energy-Efficient Electric Vehicles Project;"

WHEREAS, Special Order No. SO2014-05-0014 "Designating Additional Members to the Project Steering Committee" in relation to DO2014-02-0005 was issued on 19 May 2014;

NOW, THEREFORE, for and in consideration of the foregoing premises, the specific provisions of DO2014-02-0005 are hereby amended as follows:

 Inclusion of Land Transportation Office and the Department of Budget and Management as members of the Project Steering Committee under Item 1.

Item 1

Creation of Project Steering Committee and Project Management Unit. A Project Steering Committee and a Project Management Unit (herein referred to as "PSC" and "PMU") are hereby created in the DOE.

The PSC shall provide overall guidance and shall approve key program activities including fund commitments of the project. It shall be composed of duly designated representatives from the Department of Finance, Department of Interior and Local Government, Department of Trade and Industry, Department of Transportation and Communications — Land Transportation

 Change in position title from "OIC-Director of EUMB" to "Director of EUMB and inclusion of CWPO as member of the Communication/Social Mobilization under Item 3.

Item 3

"Designation of PSC Chair, PMU Director, E-Trike Operations and LGU Operations Managers, Heads of Support Services and the Secretariat. The Supervising Undersecretary of the Energy Utilization and Management Bureau (EUMB) and the <u>Director of EUMB</u> are hereby designated as PSC Chair and PMU Director, respectively."

"The E-Trike Operations shall be headed by the OIC-Assistant Director of EUMB who shall be assisted by a Deputy who is the Chief Science Research Specialist of the Alternative Fuels and Energy Technology Division (AFETD). The Technical, Communication/Social Mobilization, Capacity Building and Monitoring and Evaluation shall be composed of personnel from AFETD, EUMB, Consumer Welfare and Promotion Office (CWPO) and HRMD."

 Effectivity. This Department Order shall take effect immediately upon signing and shall be valid until the full and complete termination or cancellation of the Project as when revoked by competent authority.
