QTPBAC Resolution No. 01 Series of 2022

A RESOLUTION RECOMMENDING THE AWARD FOR THE PROVISION OF QUALIFIED THIRD-PARTY SERVICES FOR THE CONSTRUCTION, OPERATION AND MAINTENANCE OF GENERATION AND DISTRIBUTION SYSTEM, AND BILLING AND COLLECTION FOR THE QTP SERVICE AREAS OF THE PALAWAN ELECTRIC COOPERATIVE (PALECO) TO THE CONSORTIUM OF MAHARLIKA CLEAN POWER HOLDINGS CORP., CLEAN GRID PARTNERS PTE LTD AND WENERGY GLOBAL PTE LTD

WHEREAS, based on the Comprehensive Electrification Masterplan, a total of 35 areas were identified as QTP Service Areas under the Palawan Electric Cooperative's (PALECO) franchise coverage;

WHEREAS, pursuant to Department of Energy's (DOE) Department Circular DC2019-11-0015, a Notice to Proceed dated October 04, 2021 was issued by the National Electrification Administration (NEA) authorizing PALECO through the formation of a Qualified Third-Party Bids and Awards Committee (QTPBAC) to conduct a Competitive Selection Process (CSP) for the Provision of Qualified Third-Party Services for the construction, operation and maintenance of generation and distribution system, and billing and collection for the QTP Service Areas;

WHEREAS, an Invitation to Bid (ITB) was published on November 19, 2021 issue of the Philippine Daily Inquirer and in the PALECO website;

WHEREAS, the Pre-bid Conference was conducted on April 04, 2022 which was participated by seven (7) bidders; while, only three (3) bidders continued their participation during the Submission and Opening of Bids on May 12, 2022 namely;

Maharlika Clean Power Holdings Corp., PowerSource Philippines, Inc. (PSPI) and New Belvia Renewables Inc.

WHEREAS, during the evaluation of bids, PowerSource Philippines, Inc. (PSPI) and New Belvia Renewables Inc. were declared non-compliant due to failure to submit the complete set of required documents resulting for Maharlika Clean Power Holdings Corp. as the only one to pass the eligibility and technical requirements;

WHEREAS, Maharlika Clean Power Holdings Corp. is in consortium with Clean Grid Partners Pte Ltd and WEnergy Global Pte Ltd and as a consortium they submitted their technical and financial proposals for Lots No. 4, 5, 6, 10, 11, 14, 15, 16, 17, 18, 19, 20, 21 and 22:

WHEREAS, Maharlika Clean Power Holdings Corp. submission of technical and financial proposals for Lots No. 4 and 6 were declared non-compliant due to presentation of combined proposal that is nonconforming to the requirement of a per lot basis as prescribed in the Bidding Procedures/Guidelines;

WHEREAS, Maharlika Clean Power Holdings Corp. tendered its financial proposals, as follows:

- b. To recommend the award of 10-year contract for the Provision of Qualified Third-Party Services for the construction, operation and maintenance of generation and distribution system, and billing and collection for the QTP Service Areas
